# **EXPLANATORY NOTES ON COSTS OF FORMER PARLIAMENTARIANS TRAVEL 1 JULY TO 31 DECEMBER 2008**

## **Background**

On 27 September 2001, the then Prime Minister announced that expenditure by former Governors-General, former Prime Ministers, other Life Gold Pass Holders, severance travel beneficiaries and widows of certain eligible former Parliamentarians, arising from benefits granted to them in recognition of public service, would be publicly disclosed.

The statement further indicated that this disclosure would be done on a six-monthly basis as a separate statement tabled in conjunction with the standard statement of Parliamentarians' expenditure. The document would contain the same level of detail, in the relevant category, as for Parliamentarians.

## **Process of Compilation**

The Department of Finance and Deregulation (Finance) prepared reports regarding the expenditure and adjustments of travel costs (where applicable) for former Prime Ministers, other Life Gold Pass Holders, Severance Travellers, Widows of former Prime Ministers and Widows of other Life Gold Pass Holders.

The detailed information was provided to each person in order for him or her to clear the documentation or advise of any corrections required. When such advice was provided to Finance, it was checked against the source data (such as invoices and records of payment). Provided these agreed with the amendments advised by the individual former Parliamentarian or Widow, Finance's records were adjusted and the draft tabling document was amended.

A copy of amendments was provided to each former Parliamentarian or Widow who requested changes. Finally a set of the individual's documents in the tabling format was provided for information.

Based on the process outlined above, the information contained in this document is considered to be an accurate statement of payments made, and receipts, during the period 1 July to 31 December 2008 in respect of travel for eligible former Parliamentarians and Widows.

## **Notes on the information tabled**

The information tabled relates to *payments made*, and *receipts*, by Finance during the period 1 July to 31 December 2008, not necessarily for travel *actually undertaken* during the period. This is due to the fact that accounts (payments and receipts) sometimes are processed in a period other than when the travel takes place. The reasons include receipt and payment of invoices after a period ends, advance bookings made and paid for in one period and used in a subsequent reporting period and recrediting costs in a later period for a cancelled booking in an earlier period.

Goods and services purchased by Finance on behalf of former Parliamentarians are reported exclusive of recoverable Goods and Services Tax (GST). This is in accordance with the requirement that all agencies report all expenditure as exclusive of recoverable GST.

Appropriate annotations have been made on the documentation.

The tabled information comprises:

- aggregate information on travel entitlements for all eligible former Parliamentarians and Widows; and
- summary information particular to each former Parliamentarian and Widow on costs incurred and any repayments to Finance in the various categories of travel entitlements for two separate reporting periods:-
  - ▶ travel paid between 1 July and 31 December 2008 and undertaken on or after 1 July 2008; and
  - ▶ travel paid between 1 July and 31 December 2008 and undertaken prior to 1 July 2008.

### **Supporting Information**

The supporting information, which is too bulky to be tabled but is available on written request to the Office of the Special Minister of State, is also broken into two separate reporting periods:-

- travel paid between 1 July and 31 December 2008 and undertaken on or after 1 July 2008; and
- travel paid between 1 July and 31 December 2008 and undertaken prior to 1 July 2008.

Transactions associated with the following travel costs are included in the supporting documentation:

- domestic scheduled fares;
- Private-Plated Vehicle (for former Prime Ministers only);
- COMCAR (for former Prime Ministers only); and
- accumulation and use of airline loyalty points (accrued at official expense).

### **Former Governors-General**

If the Hon Bill Hayden travels under his Life Gold Pass entitlement, Finance meets the costs of his usage of scheduled services. The Department of the Prime Minister and Cabinet meets any other travel costs for former Governors-General.

## Notes on Columns in Summary Tabling Document

- (1) **Domestic Scheduled Fares:** *these are payments made by Finance (incorporating any refunds received) between 1 July and 31 December 2008 for purchase of tickets on domestic scheduled services.*

This total does not necessarily cover the cost of all flights taken in the period. Travel may have been undertaken before the beginning of the period but the account paid during the period. Travel may have been undertaken during the period but the account paid in a subsequent period.

- (2) **Private-Plated Vehicle** (for former Prime Ministers only): *these are payments for the hire, insurance, maintenance costs and fuel costs of Australian Government leased Private-Plated Vehicles between 1 July and 31 December 2008.*

The figures may include lease and other costs before 1 July 2008.

- (3) **COMCAR:** *this is the cost of COMCAR trips billed in respect of former Prime Ministers during the period 1 July to 31 December 2008.*

The figures would include any parking costs when a private vehicle is driven to the airport in lieu of using COMCAR.

- (4) **Airline Loyalty Points Accumulated (Approximated):** *this represents the approximated number of airline loyalty points accumulated, as calculated by Finance, for flights undertaken on official travel for which payments have been made between 1 July and 31 December 2008. Whilst points may vary between airlines, including travel on the same sectors, the amount shown is an aggregated total of points accumulated in the period with all airlines (e.g. QANTAS, Virgin Blue or Jetstar).*

- (5) **Airline Loyalty Points Notified to Finance as Redeemed:** *this represents the approximated number of airline loyalty points redeemed, as calculated by Finance, on flights undertaken on official travel and reported between 1 July and 31 December 2008. These flights were funded by the use of airline loyalty points accrued in respect of previous Commonwealth funded travel.*

Figures are based on returns provided by former Parliamentarians and widows and may not include all use of airline loyalty points.

- (6) **Airline Loyalty Points Usage:** *this represents the equivalent cost of airfares for flights undertaken on official travel and reported between 1 July and 31 December 2008 and funded by the use of airline loyalty points accrued in respect of previous Commonwealth funded travel.*

Figures are based on returns provided by former Parliamentarians and widows and may not include all use of airline loyalty points.
