## **EXPLANATORY NOTES ON COSTS OF PARLIAMENTARY TRAVEL 1 JULY TO 31 DECEMBER 2008**

### **Process of Compilation**

In accordance with past practice, the Department of Finance and Deregulation (Finance) prepared draft tables in respect of expenditure, and adjustments, of travel and Travelling Allowance costs and travelling expenses for each Senator and Member. It also includes advice obtained from Departments on those car transport costs met by them in respect of individual Ministers, Parliamentary Secretaries, and Presiding Officers.

The detailed information was provided to each Senator and Member in order for him or her to clear the documentation or advise of any corrections required. When such advice was provided to Finance, it was checked against the source data (such as invoices and records of payment). Provided these agreed with the amendments advised by the individual Senator or Member, Finance records were adjusted and the draft tabling document was amended.

A copy of amendments was provided to each Senator and Member who requested changes. Finally a set of the individual's documents in the tabling format was provided for information.

Based on the process outlined above, the information contained in this document is considered to be an accurate statement of payments made, and receipts, during the period 1 July to 31 December 2008 in respect of travel and Travelling Allowance and travelling expenses of Senators and Members.

### **Notes on the information tabled**

The information tabled relates to *payments made*, and *receipts*, by Finance during the period 1 July to 31 December 2008, not necessarily for travel *actually undertaken* during the period. This is due to the fact that accounts (payments and receipts) sometimes are processed in a period other than when the travel takes place. The reasons include receipt and payment of invoices after a period ends, advance bookings made and paid for in one period and used in a subsequent reporting period and recrediting costs in a later period for a cancelled booking in an earlier period.

Goods and services purchased by Finance on behalf of Senators and Members are reported exclusive of recoverable Goods and Services Tax (GST). This is in accordance with the requirement that all agencies report all expenditure as exclusive of recoverable GST.

Appropriate annotations have been made on the documentation.

The tabled information comprises:

- aggregate information on travel entitlements for all Senators and Members;
- summary information particular to each Senator and Member on costs incurred and any repayments to Finance in the various categories of travel entitlements for two separate reporting periods:-
  - ▶ travel paid between 1 July and 31 December 2008 and undertaken on or after 1 July 2008;
  - ▶ travel paid between 1 July and 31 December 2008 and undertaken prior to 1 July 2008; and
- details of payments of Travelling Allowance made by Finance and of any repayments.

## **Supporting Information**

The supporting information, which is too bulky to be tabled but is available on written request to the Office of the Special Minister of State, is also broken into two separate reporting periods:

- travel paid between 1 July and 31 December 2008 and undertaken on or after 1 July 2008; and
- travel paid between 1 July and 31 December 2008 and undertaken prior to 1 July 2008.

Transactions associated with some of the following travel costs are included in the supporting documentation:

- domestic scheduled fares;
- charter (eg. Charter as Minister, Opposition Office Holder and Leader of Minority Party, Charter within Electorate, Charter Representing a Minister or Special Approval Charter where appropriate);
- Private Vehicle Allowance;
- Private-Plated Vehicle(s);
- COMCAR;
- other car costs;
- overseas travel; and
- accumulation and use of airline loyalty points (accrued at official expense).

## Notes on Columns in Summary Tabling Document

- (1) **Domestic Scheduled Fares:** *these are payments made by Finance (incorporating any refunds received) between 1 July and 31 December 2008 for purchase of tickets on domestic scheduled services.*

This total does not necessarily cover the cost of all flights taken in the period. Travel may have been undertaken before the beginning of the period, or booked for travel in a subsequent period, but the account paid during the period. Travel may have been undertaken during the period but the account will be paid for in a subsequent period. The figure also includes cases where a Senator or Member, instead of taking a scheduled service to which he or she was entitled, used charter transport and paid any excess cost which was incurred.

- (2) **Charter:** *these are payments made between 1 July and 31 December 2008 to charter operators for provision of air or surface charter transport.*

The charter entitlement is available to Members representing large electorates and all Senators (except those representing the Australian Capital Territory) in and for the service of their State or the Northern Territory, and to Ministers, Opposition Office Holders, and leaders of a Minority Party for official business. There is also provision for the Special Minister of State to approve charter travel in special cases. Where there is a payment made during the period, it has been further categorised as Charter as Minister (or Opposition Office Holder Charter, or Leader's Charter), Charter within Electorate, Charter Representing a Minister or Special Approval Charter.

- (3) **Private Vehicle Allowance:** *these are payments to Senators and Members between 1 July and 31 December 2008 for the use of their private vehicles for travel between Canberra and home base on parliamentary business.*

- (4) **Private-Plated Vehicle:** *these are payments for the hire, insurance, maintenance costs and fuel costs of Australian Government leased Private-Plated Vehicles between 1 July and 31 December 2008. Where an end of lease adjustment has been made under the terms of the lease during the period, this payment has been annotated accordingly in the documentation.*

Senators and Members may elect to receive payment in lieu of the Private-Plated Vehicle made available under Clause 5.1, 5.2 or 5.4 of *Remuneration Tribunal Determination 2006/18*. The administration of the payment is the responsibility of the relevant Chamber Department.

Where Senators and Members make financial contributions, these have been reflected in the tabling document.

- (5) **COMCAR:** *this is the cost of COMCAR trips billed for each Senator and Member during the period 1 July to 31 December 2008.*

The figures exclude costs associated with the Parliament House shuttle service.

This item may include the cost of spouse/nominee use of COMCAR when travelling within entitlement.

- (6) **Other Car Costs:** *these are payments and adjustments made against Cabcharge, Canberra-based Private-Plated Vehicles and invoices for hire cars not supplied through COMCAR for the period 1 July to 31 December 2008.*

The totals include, for Ministers, Parliamentary Secretaries and Presiding Officers, the cost of car transport paid by their portfolio Departments.

- (7) **Travelling Allowance:** *these are payments made by Finance to Ministers, Parliamentary Secretaries, Presiding Officers, Opposition Office Holders, and Senators and Members between 1 July and 31 December 2008.*
- (8) **Overseas Travel:** *these are payments made between 1 July and 31 December 2008 for travel overseas by:*  
- *Ministers, former Ministers, Presiding Officers, the Leader and Deputy Leader of the Opposition and their representatives (and accompanying spouses and staff costs);*  
- *Senators and Members on parliamentary delegations and study tours.*
- (9) **Airline Loyalty Points Accumulated (Approximated):** *this represents the approximated number of airline loyalty points accumulated, as calculated by Finance, for flights undertaken on official travel for which payments have been made between 1 July and 31 December 2008. Whilst points may vary between airlines, including travel on the same sectors, the amount shown is an aggregated total of points accumulated in the period with all airlines (e.g. QANTAS, Virgin Blue or Jetstar).*
- (10) **Airline Loyalty Points Notified to Finance as Redeemed:** *this represents the approximated number of airline loyalty points redeemed, as calculated by Finance, on flights undertaken on official travel and reported between 1 July and 31 December 2008. These flights were funded by the use of airline loyalty points accrued in respect of previous Commonwealth funded travel.*

Figures are based on returns provided by Senators and Members and may not include all use of airline loyalty points.

- (11) **Airline Loyalty Points Usage:** *this represents the equivalent cost of airfares for flights undertaken on official travel and reported between 1 July and 31 December 2008 and funded by the use of airline loyalty points accrued in respect of previous Commonwealth funded travel.*

Figures are based on returns provided by Senators and Members and may not include all use of airline loyalty points.

## Notes on Travelling Allowance and Travelling Expenses

The Remuneration Tribunal determines the rates of Travelling Allowance for Ministers, Office Holders and other Senators and Members and the conditions under which such allowances are paid.

During the period 1 July to 31 December 2008 the operative determinations were *Remuneration Tribunal Determination 2006/18, 2007/15 and 2008/15*.

Determinations contain a number of clauses setting out the circumstances when Travelling Allowance is payable. These are as follows:

Clause No.	Provision
2.5	- the amount the Prime Minister is entitled to be paid for accommodation and sustenance when staying overnight in a place other than an official establishment;
2.6	- the circumstances when Travelling Allowance is payable to Ministers, the Presiding Officers, the Opposition Office Holders, the Deputy President and Deputy Speaker, Chairman of Committees in the Senate and the Leader of a recognised party of at least five members in the Parliament;
2.6.2	- the allowance payable to Ministers for meals where accommodation costs are met by the Australian Government, except where the mode of transport includes an en route accommodation component;
2.7	- the allowance payable to the Deputy Prime Minister when acting as Prime Minister;
2.8	- the allowance payable in respect of an accompanying spouse of a Minister or Office Holder (listed in clause 2.6 above);
2.9	- entitlement for Travelling Allowance for a required stopover for a Minister or Office Holder (listed in clause 2.6 above) travelling between Western Australia or the Northern Territory and Canberra;
2.10	- the circumstances when Travelling Allowance is payable to Senators and Members;
2.11	- entitlement for Travelling Allowance for a required stopover for a Senator or Member, when travelling between Western Australia or the Northern Territory and Canberra;
2.13	- entitlement for Travelling Allowance for a Senator or Member, whose electorate is 10,000km <sup>2</sup> or more in area, when travelling within the electorate on parliamentary or electorate business;



- 2.14 - entitlement for daily expense allowance for Senators and Members from the Australian Capital Territory and Members representing an electorate adjacent to the Australian Capital Territory;
- 2.15 - entitlement for Travelling Allowance for a Senator from the Northern Territory or the Member for Lingiari (in relation to visits to Cocos (Keeling) and Christmas Islands) and Senators from the Australian Capital Territory and the Member for Canberra (in relation to Norfolk Island) for travel for electorate purposes;
- 2.16 - entitlement to Travelling Allowance when a Senator from the Northern Territory or the Member for Lingiari is required to break his or her journey when travelling to or from the Cocos (Keeling) or Christmas Islands;
- 2.17 - entitlement to Travelling Allowance when a Senator or Member visits an external territory (other than Antarctica) on parliamentary business;
- 2.19 - entitlement to Travelling Allowance for the Leader of a recognised party of at least five members in the Parliament;
- 2.20 - entitlement to Travelling Allowance for the Deputy Leader of a recognised party of at least five members in the Parliament;
- 2.21 - entitlement of the Second Deputy Speaker to Travelling Allowance when carrying out duties or functions associated with that office;
- 2.22 - entitlement to Travelling Allowance of the Chief Whips of all parties in either the Senate or the House of Representatives, when travelling to Canberra on duties or functions connected with their offices, other than when Parliament is sitting;
- 2.23 - entitlement to Travelling Allowance for the Whips of all parties in either the Senate or the House of Representatives, when travelling to Canberra on duties or functions connected with their offices at the request of, or in the place of, the Chief Whip, other than when Parliament is sitting;
- 2.24 - entitlement of a chair of a Parliamentary Committee to Travelling Allowance;
- 2.25 - entitlement of a Shadow Minister to Travelling Allowance.

In the documentation which follows, a single number in the clause/determination column indicates the clause under which Travelling Allowance on a particular day was claimed (eg. 10a indicates clause 2.10 of *Determination 2008/15*).
