Sorry for the delay in replying to your e-mail.

The issue we discussed briefly when we met in Adelaide was not raised by anyone at Defence.

I mentioned that the document that ASC provided to frigate designers, 'A Winning Shipbuilding Solution for the SEA 5000 Program' attributed a number of comments to Ministers including Minister Cormann. I said in our conversation that I think, and the relevant advisor in Minister Cormann's Office also thinks, that it would be best to consult with the Minister's Office, prior to attributing the Minister's views in a publication or a document such as the one mentioned above.

I don't think any action is needed, I just raised the issue for consideration with respect to the production of future documents.
