Following our conversation earlier today I can confirm that ownership of the attached Committee questions rests with ASC.

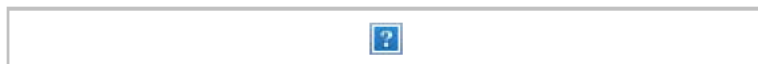

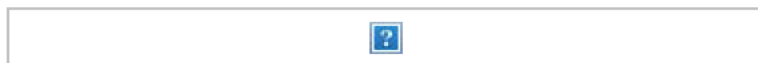
