Key Issues:

Senator O'Sullivan wrote to you on 12 September 2017, requesting confirmation that the Commonwealth has not engaged in any direct or indirect contracts with Newlands Civil Construction Pty Ltd (Attachment B).


2. Finance has conducted a search on AusTender, the Australian Government's procurement information system to determine whether Newlands Civil Construction Pty Ltd is recorded as having being awarded any Commonwealth contracts.
3. It is a requirement that all contracts entered into by Commonwealth entities, that meet certain reporting thresholds, are recorded on AusTender. AusTender has been the Australian Government's procurement information system since July 2007 and shows details of contracts entered into since that time.
4. As at 13 September 2017, AusTender shows:
 - (a) no direct contracts with Newlands Civil Construction Pty Ltd, valued at \$10,000 or above, with any non-corporate Commonwealth entity; and
 - (b) no direct contracts with Newlands Civil Construction Pty Ltd, valued at \$400,000 or above, with any prescribed corporate Commonwealth entity
5. Finance is not able to provide details of any contracts valued below the reporting thresholds outlined above, any indirect contracts such as subcontracting arrangements, or any contracts with non-prescribed entities, as these are not captured on any whole-of-government reporting systems.





Thank you for your letter of 12 September 2017 concerning Newlands Civil Construction Pty Ltd (ABN 133 339 778).

In response to your letter I asked the Department of Finance (Finance) to conduct a search of AusTender, the Australian Government's procurement information system, to determine whether Newlands Civil Construction Pty Ltd is recorded as having being awarded any Commonwealth contracts.


It is a requirement that all contracts entered into by Commonwealth entities, that meet certain reporting thresholds, are recorded on AusTender.
