









WoAG Travel Advice 2018/17

Subject: Car Rental - Government Fuel Prices

Issue date: 15 October 2018

This advice provides entities with information on fuel pricing for car rentals booked under the Whole of Australian Government (WoAG) Car Rental Arrangement (the Arrangement).

Please note that this advice supersedes *WoAG Travel Advice 2018/07: Car Rental – Government Fuel Prices* issued on 10 April 2018.

Fuel Charges

Under the Arrangement, the Government Fuel Price for each car rental provider is reviewed and agreed by the Department of Finance (Finance) on a quarterly basis.

Europear and Thrifty will adjust their Government Fuel Price (GFP) with effect from **15 October 2018**. For the period from 15 October 2018 to 15 January 2019, the GFP for each car rental provider is as follows:

Europcar	Fuel rate:	\$1.75 per litre exclusive of GST (\$1.92 GST incl.)				
Thrifty Fuel rate:		\$1.39 per litre exclusive of GST (\$1.53 GST incl.)				

Europcar

Europear applies a fuel charge for each car rental based on the number of litres of fuel used during the rental period. The fuel charge for each rental is calculated by multiplying the total litres used by the GFP. The total litres used are calculated by adding the litres of fuel purchased using the fuel card (where applicable) and the litres required to refill the tank (in the event that the vehicle was returned with less than a full tank).

If the traveller is unable to refuel the vehicle using the fuel card provided and another form of payment was used to purchase fuel, then a tax invoice/receipt detailing the litres purchased must be kept and provided to the entity for a refund, where applicable.

Thrifty

Thrifty applies a fuel charge based on the total kilometres driven during the car rental period for the vehicle class rented. The fuel charge for each car rental will be calculated using the pre and post rental odometer readings multiplied by the cents per kilometre applicable for the vehicle class rented. The fuel rates from 15 October 2018 to 15 January 2019 are at <u>Attachment A</u>.

If the traveller is unable to refuel the vehicle using the fuel card provided and another form of payment is used to purchase fuel, then a tax invoice/receipt must be obtained from the service station detailing the cost and litres purchased. To request a refund, please forward the tax invoice/receipt, Rental Agreement Number and the relevant credit card details to Thrifty's WOAG Customer Service e-mail address: WOAGovernment.CustomerService@thrifty.com.au.

Invoices

Where required by an entity, the car rental providers can provide a final invoice following reconciliation of the fuel card purchases and end of trip fuel charges.
