In November 2019, the Department of Finance (Finance) updated the Finance website. The July Grants Community of Practice Forum provided an opportunity to gather views on the existing grants webpages on the website and workshop what people would like to see improved.

The feedback we received from attendees was primarily focused on the accessibility of Grants information, but also touched on the need for This feedback complements our analysis of queries that entities, providers and recipients send to Finance. We have taken this information and have incorporated feedback from our various stakeholders into the redesign of the grants webpages. This is the first phase of the grants webpages redesign project.

GrantConnect Statistics

GrantConnect is the single point of discovery for all Australian Government Grant Opportunities since 30 April 2017, and Grants Awarded information since 31 December 2017.

GrantConnect statistics as at 10 December 2019:

- Approx. 42,100 public Registered Users, 430 Entity Users
- 3.2 million opportunity notifications emails have been sent to Registered Users
- 98 Forecast Opportunities published (72 linked to Grant Opportunities)
- 785 Grant Opportunities published with 113,000 downloads of grant documents
- Approx. 46,500 Grant Awards published with a total value of \$28.4 billion

How to register for GrantConnect

Registering on GrantConnect is a simple three step process, when completed will notify you of new opportunities and enable you to access information on GrantConnect.

- Select 'New User Registration' (top right of screen)
- 2. Set up your preferences
 - Select from Categories, or provide Keywords within your area of interest
- 3. Activate the account
 - The link provided in the confirmation email must be actioned within 14 days or the account will be suspended.

Most importantly registration is free.
