- @ All NCEs are able to use the repayments special appropriation in section 77 of the *Public Governance, Performance and Accountability Act 2013* (PGPA Act), if the expenditure is consistent with the legislative provisions. Therefore, the totals figures listed next to each portfolio and entity, and the totals figures at the top of the page, do not include this Act (even though the PGPA Act and section are still included in the Acts lists for the NCEs). The exception is in the totals for the Finance portfolio. This ensures that the repayments provision is only counted once. NCEs which only use a single special appropriation, that of section 77, are listed as having no special appropriations for the purposes of the totals.

A special appropriation (also known as a 'standing appropriation') is a legal mechanism contained within an Act that is not an annual appropriation Act, whereby the Parliament authorises the Executive to expend money from the Consolidated Revenue Fund for specific purposes. (See sections 81 and 83 of the Constitution.) Expenditure from a special appropriation can be made only for the legislated purposes of that appropriation.

This Chart (available [on the Finance website here](#)) lists Acts containing special appropriation provisions, under the non-corporate Commonwealth entity (NCE) that is responsible for administering them. A special appropriation may be administered by more than one NCE. (If so, the Act will appear under two or more NCEs.) Acts that are amendments, transitional or relate to the functions of a primary Act, are collected under that primary Act. The name of each Act listed in this Chart is [hyperlinked](#) to the legislation on the Federal Register of Legislation.

NCEs which have special accounts rely on the special appropriations in sections 78 or 80 of the PGPA Act. This Chart does not include special accounts, which are a subset of special appropriations. The Chart also does not include 'statutory credits', which are provisions whose sole purpose is to increase the balance of a special account.
