# **Participating Agency Information**

## Australian Electoral Commission

The Australian Electoral Commission is responsible for undertaking the largest peace time logistical event in Australia - the federal election. The Australian Electoral Commission maintains an impartial and independent electoral system for eligible voters through active electoral roll management and efficient delivery of polling services.

When not in an election cycle, the Australian Electoral Commission is involved in community engagement and outreach programs, facilitating federal by-elections, union elections and referendums.

# Bureau of Meteorology

The Bureau's purpose, as defined by its mission is to provide trusted, reliable and responsive weather, water, climate and ocean services for Australia—all day, every day.

The Bureau of Meteorology is Australia's national weather, climate and water agency. Its expertise and services assist Australians in dealing with the harsh realities of their natural environment, including drought, floods, fires, storms, tsunami and tropical cyclones. Through regular forecasts, warnings, monitoring and advice spanning the Australian region and Antarctic territory, the Bureau provides one of the most fundamental and widely used services of government.

The Bureau contributes to national social, economic, cultural and environmental goals by providing observational, meteorological, hydrological and oceanographic services and by undertaking research into science and environment related issues in support of its operations and services.

The Bureau of Meteorology operates under the authority of the Meteorology Act 1955 and the Water Act 2007. The Bureau of Meteorology must also fulfil Australia's international obligations under the Convention of the World Meteorological Organization (WMO) and related international meteorological treaties and agreements. Be part of an organisation of global standing, highly valued by the community for our pivotal role in enabling a safe, prosperous, secure and healthy Australia.

## National Recovery & Resilience Agency

The National Recovery and Resilience Agency's work has a real impact on the lives of Australians, particularly those living in rural and regional areas.

The Agency's guiding principle is "Locally led, locally understood and locally implemented" and we bring together local communities, government, non-government and key industry representatives to support disaster recovery and resilience across the country.

Your work will help people who are recovering from natural disasters and prepare them for the future.

## National Health Funding Body

The National Health Funding Body (NHFB) is a workplace committed to providing an environment that values diversity and supports staff to reach their full potential.

The NHFB values health and wellbeing of employees and offers a range of benefits to support staff including:

- Flexible work arrangements
- Positive workplace culture encouraging work-life balance
- Supportive and inclusive work environment.



In the 2021 Australian Public Service Employee Census the NHFB was ranked first from 101 agencies when it comes to both 'Engagement' and 'Innovation' and third for 'Wellbeing' including 100% of staff indicating they're proud to work in the agency.

The Administrator of the National Health Funding Pool (the Administrator) and the National Health Funding Body (NHFB) were established through the Council of Australian Governments National Health Reform Agreement (NHR Agreement) of August 2011.

The primary functions of the NHFB are to assist the Administrator in:

- Calculating and advising the Commonwealth Treasurer of the Commonwealth's contribution to public hospital funding in each State and Territory (over \$24 billion in 2021-22)
- Reconciling estimated and actual public hospital services, and adjusting Commonwealth payments (over 39 million records each year)
- Undertaking funding integrity analysis to identify public hospital services that potentially received funding through other Commonwealth programs (over 595 million records)
- Monitoring payments of Commonwealth, State and Territory public hospital funding into the National Health Funding Pool (the Pool)
- Making payments from the Pool to each Local Hospital Network (LHN)
- Reporting publicly on funding, payments and services
- Developing and providing three-year data plans to the Commonwealth, States and Territories.

# National Health and Medical Research Council

The National Health and Medical Research Council (NHMRC) funds high quality health and medical research, builds research capability, supports the translation of health and medical research into better health outcomes and promotes the highest standards of ethics and integrity in health and medical research.

An important part of NHMRC's activities is maintaining a leadership role in the development of public and environmental health and clinical advice designed to prevent illness, improve health, enhance clinical care and support the states and territories in achieving consistent standards.

NHMRC is responsive to national health priorities, to researchers, to consumer needs and community perspectives and to the requirements and directions of government. NHMRC also works closely with the Department of Health to support delivery of Medical Research Future Fund (MRFF) measures.

# Attorney-General's Department

We deliver programs and policies to maintain and improve Australia's law and justice framework. Through the Australian Government Solicitor, we also provide legal services to the Commonwealth, including legal advice and representation.
