## 25 JULY 2022 QUARTERLY REPORT

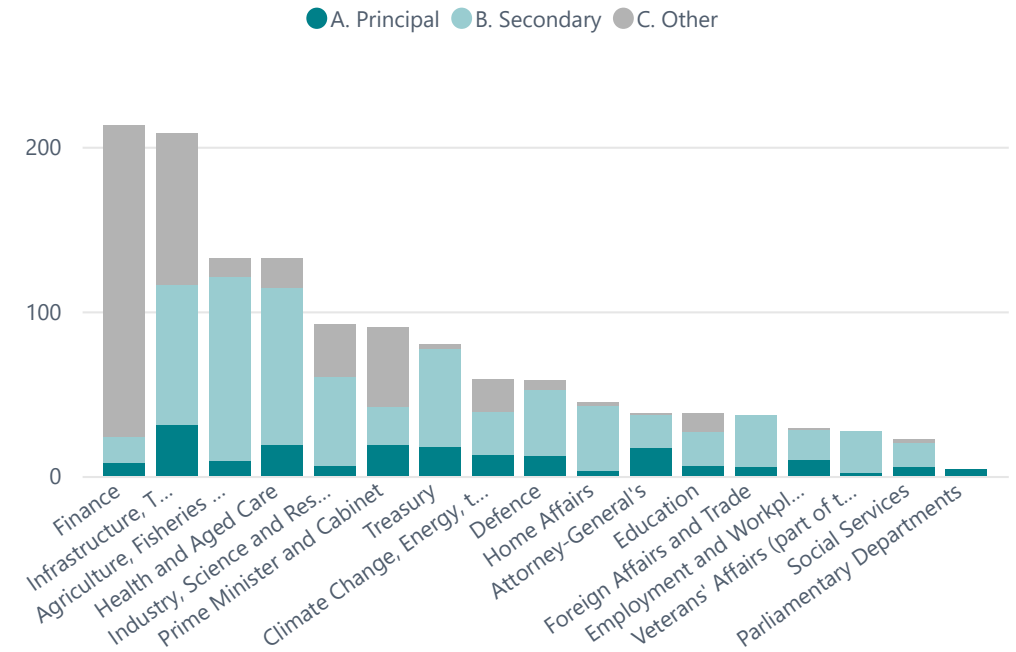
The Australian Government Organisations Register provides information on the function, composition, origins and other details of Australian Government bodies.

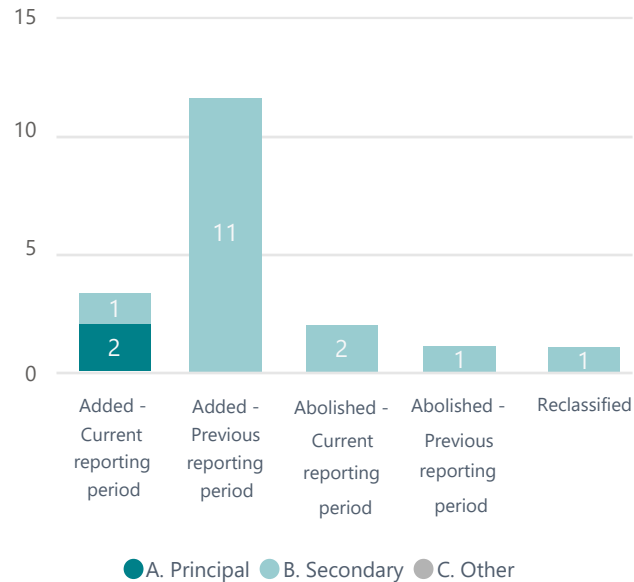
