Since our last update in May, there have been some significant milestones achieved on the National Security Office Precinct Project.

## **Government Approvals**

As the John Gorton Campus Car Park is located in the Parliamentary Zone, the development was subject to Parliamentary Approval under the *Parliament Act 1974*. This submission was facilitated by the National Capital Authority and the Hon Kristy McBain MP, Minister for Regional Development, Local Government and Territories. Parliamentary Approval was ratified in both houses on 11 May 2023. This is a great outcome and continues on-time progression along the approval pathway for the development.

The NCA Works Approval submission is continuing to be progressed and is anticipated shortly.

# JGC Car Park – Closure & Construction

Subject to the outcome of NCA Works Approval, the closure of the existing on-grade car park is expected in July 2023, to enable construction commencement.
