# John Gorton East Car Park Closure

Fact Sheet - 7 July 2023

### When will the John Gorton East Car Park close?


The John Gorton East Car Park will close from <u>17 July 2023</u> (subject to final National Capital Authority approval). Dorothy Tangney Place will also close at this time.

## Will accessible parking be impacted?

There will be 21 accessible car parks closed as part of the John Gorton Campus Car Park development. These accessible car parks will be relocated to the front row of the John Gorton South Car Park (map refers). Works to relocate these car parks will be completed prior to the closure of the car park.





# What are the pedestrian access paths around the car park closure?

### **Pedestrian Path Access**

The closure of the John Gorton East Car Park will change pedestrian access points surrounding the John Gorton Building. The below map outlines the construction site perimeter (blue) that is due to close from 17 July 2023, and shows the outline of pedestrian pathways around the site (green) including from the Kings Avenue Bus Stop No. 3028. Construction vehicles will use the Dorothy Tangney Place roundabout entrance as primary access to the site.



### **Bus Stop Changes**

The car park's development will include impacts to the current Bus Stop on Kings Avenue (Bus Stop No. 3028) at a later date. The Department of Finance is working with the NCA and the ACT Government on the best location of the new bus stop.

Further information will be issued once the specific location and impacts are known.



# **Consultation Update**

In approaching the closure of the John Gorton East Car Park, the Department of Finance has engaged heavily with impacted stakeholder through a number of channels, including:

- in-person and virtual 'Pop Up' sessions involving a number of nearby stakeholders including the Department of Climate Change, Energy, the Environment and Water, the Australian Federal Police, the Department of the Prime Minister and Cabinet and tenants of 4 National Circuit
- Regular e-newsletters, Fact Sheets and website updates.
- Briefings to the CPSU.

The Department of Finance will continue to engage with impacted stakeholders as part of the car park closure, providing as much information as possible. This will include signage being installed on site notifying of the closure and also other public notices.
