JGC Car Park – Closure & Construction Update

The existing on-grade John Gorton East Car Park and Dorothy Tangney Place will close from **17 July 2023***, to allow for the construction of the new car park which is anticipated to be completed in late 2024.

Accessible Car Parks

The closure of the John Gorton East Car Park will impact 21 accessible car parks.

In consultation with the NCA, the accessible car parks will be relocated to the John Gorton South Car Park during the construction phase of the project.

This work will be completed prior to the closure of these car spaces within the John Gorton South Car Park.

York Park Site - Investigations

Finance's Managing Contractor for the National Security Office Precinct – Lendlease, will be undertaking preliminary site investigation works at the York Park Car Park from Monday, 17 July 2023 to Friday, 18 August 2023 (5-week duration).

The Car Park will remain open, but to accommodate these works, a small number of car parks will close across the car park at different times as well as temporary fencing, noise reduction barriers and a small site compound being established.
