A special account is a legislative mechanism to appropriate up to a limited amount of Commonwealth money for spending.

Special accounts are a subset of special appropriations.

Money spent against a special account is supported by the special appropriations in the PGPA Act:

- section 78 authorises a special account to be established by legislative instrument.
- section 80 authorises a special account to be established by an Act of Parliament.

Expenditure using a special account can be only for the legislated purposes of that special account.

The name of each special account listed in this chart is hyperlinked to its establishing legislation on the Federal Register of Legislation.
