1 Name of Delegation

This Delegation is the *Public Governance, Performance and Accountability (Finance Minister to Accountable Authorities of Non-Corporate Commonwealth Entities) Amendment Delegation 2026 (No. 2)*.

2 Commencement

This Amendment Delegation commences on the date of signature.

3 Amendment of the ***Public Governance, Performance and Accountability (Finance Minister to Accountable Authorities of Non-Corporate Commonwealth Entities) Delegation 2022***

Schedule 1 amends the *Public Governance, Performance and Accountability (Finance Minister to Accountable Authorities of Non-Corporate Commonwealth Entities) Delegation 2022* that was made on 17 July 2022.

Schedule 1 Amendment to the *Public Governance, Performance and Accountability (Finance Minister to Accountable Authorities of Non-Corporate Commonwealth Entities) Delegation 2022*

[1] Schedule 1, Part 1 – *Delegation under section 53 of the Act – Banking by the Commonwealth in Australia*

At Division 2, Direction 1.9, delete the entire direction and substitute the words “There is no Direction”.

At Division 2, Direction 2.0, delete the entire direction and substitute:

Department of Defence

The exemption in Direction 1.6 applies only to the bank account(s), supporting the *Defence Endowments, Bequests and Other Trust Moneys Special Account 2019*, that relate to the production costs under:

- (a) the Boxer Heavy Weapon Carrier vehicles initiative; and
- (b) the Arctic – Over the Horizon Radar Capability.

[2] Schedule 1, Part 5 – *Delegation under section 58 of the Act – Investment by the Commonwealth*

At Division 1, Delegations, Row 3, delete “The accountable authority of the Department of the House of Representatives”.

[3] Schedule 1, Part 5 – *Delegation under section 58 of the Act – Investment by the Commonwealth*

At Division 2, Direction 5.2 delete the entire direction and substitute the words “There is no Direction”.

At Division 2, Direction 5.3 delete all the words after “special account” and before “or”.

At Division 2, Direction 5.4 delete the entire direction and substitute:

Accountable Authority of the Department of Defence

The accountable authority of the Department of Defence is permitted to invest only those amounts in the *Defence Endowments, Bequests and Other Trust Moneys Special Account 2019* that are amounts standing to the credit of the special account that are related to the production costs for:

- (a) the Boxer Heavy Weapon Carrier vehicles initiative; and
- (b) The Arctic – Over the Horizon Radar Capability.
