You have sought advice as to whether the attached 'Vote No' Advertisement may be claimed as a printing and communications work expense. Your request has been considered by Ministerial and Parliamentary Services (M&PS), which advises as follows:

- The above item complies with the requirement that it may only be used for parliamentary or electorate purposes and must not be used for party business or commercial purposes.
- The above item must be printed on paper or card weighing not more than 700 grams per square metre or on flat, magnetised material.
- As currently drafted, the above item may be claimed as a printing and communications work expense.

When using the Commonwealth Coat of Arms we refer you to Commonwealth Coat of Arms Information and Guidelines on placement and use.

Please note: you will need to complete the latest version of the <u>Printing and Communications Entitlement -</u> <u>Certification</u> (Form 141) when submitting invoices for payment. Also, please ensure that you quote, where indicated, the above **M&PS reference number**.

- Where there are no changes to the assessed item, samples are NOT required when submitting invoices.
