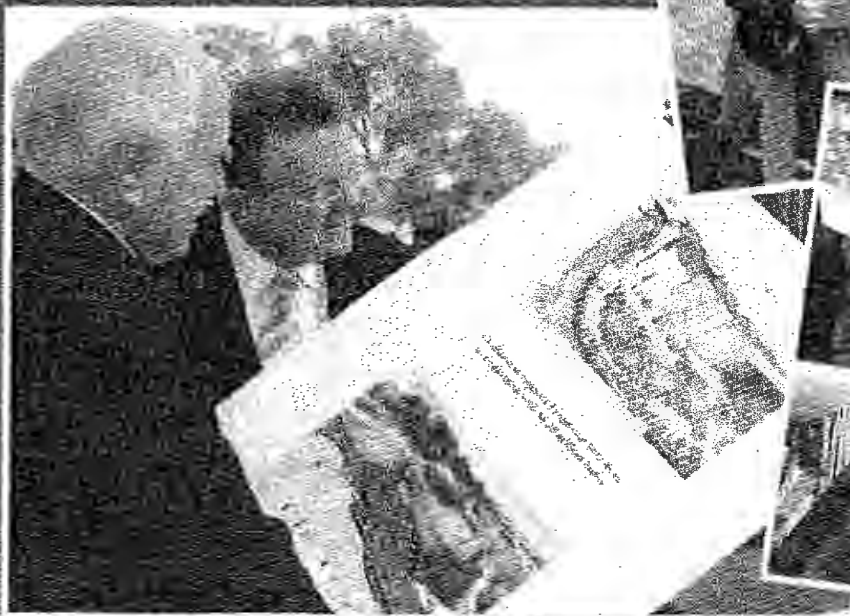

We have achieved a lot together ...

Our Dunkley community is what has shaped me and runs through my veins.

Nothing will match the great honour and privilege of representing this community where I grew up in the Australian parliament.

As I am retiring at the upcoming election after 20 years' service, this may be my last Dunkley Report. It is an opportunity to thank those who have helped me and to highlight some of what we have achieved together.

Upon learning of my decision not to contest the next election, many people with no political leanings and for sides of politics other than mine have generously passed on their thanks and appreciation.

It is this goodwill and willingness of local people to work together regardless of political allegiance that has enabled us to achieve so much ...

I say 'us' because few things in public life are achievable by a single person.

It is important to recognise the countless community and civic leaders, business people, young people with hopes for the future, office bearers and army of volunteers who make our valued community organisations tick, create new initiatives and provide the momentum for change.

These influences have guided my work. I have relished providing solutions and pathways through the web of government policy making, to find and pursue the right opportunities for our community.

It has been my aim to provide 'positive, passionate and persistent' leadership and representations to advance the interests of Dunkley and the people who live, work, invest and visit here.

Whether it be helping to navigate complex Centrelink or visa rules, assisting local businesses to export for more local jobs, making the case and leading the campaign for crucial infrastructure like the Scoresby Freeway and Frankston by-pass, or finding a creative way to turn a great local idea into reality like the Cube37 performance space or 'The Corner' youth hub – it has always been about better opportunities for our community and helping locals be their best selves.

Key to my ability to do this has been the great capacity of my office and support team.

This dedicated group of talented people are tireless in their efforts for local individuals, organisations and projects. I am indebted to this selfless assistance which has enabled me to be effective, engaged and able to achieve as the Federal Member for Dunkley.

It was possibly this local effectiveness that helped me earn the confidence of Prime Ministers Howard and Abbott to be appointed on a number of occasions to a variety of roles in the Ministry.

Enduring from these experiences is my great admiration and respect for the enterprising people of small business; the members and families of the veteran community; our Defence force serving men and women; tireless and gifted diplomats serving our nation overseas and in times of crisis like the tragic Indian Ocean tsunami; the officials of the portfolios for which I have had responsibilities; our aid

This plan of action, refreshed, refocussed and renewed for each three year parliamentary term, has been presented to the community as **Our Dunkley Destiny**. To communicate progress on the plan, I regularly reported back via this newsletter and localised Neighbourhood Bulletins.

I have reflected on some of our key **Dunkley Destiny** achievements in this edition.

It has been a long journey from my childhood in Seaford, school days at Belvedere Park and Monterey High in The Pines, early work days as a teenager at Maccas then emptying parking meters in Frankston to our nation's parliament, the Cabinet 'boardroom' of the Australian Government and to many corners of the world representing our great country.

I have loved these days – but now hope to spend more of them with those closest to me. They have made this demanding, purposeful and incredibly satisfying political life possible. It is now time to be a better and more present husband to my devoted, unceasingly supportive and bodacious wife, Kate and the best dad I can be to my precious offspring and 'mini-humans', Alex, Zoe, Maddy and Bella.

We have much to be pleased with and optimistic and proactive about our community's future. There is a delicious world of possibilities and I hope my work has enabled local people and our community to be better placed to gain more of these opportunities.

Thank you for your encouragement, support and wise counsel of my more than 20 years as the Federal Member for Dunkley. It has been a great honour and I feel very fortunate to have earned the trust and confidence of our community by being elected to the Australian parliament on seven occasions - and for what we have achieved ... together.
