Camera detected company fines are 5 times higher than individual amounts. Once a driver is nominated the fine will reduce.

9 out of 10 companies nominate the driver before the deadline. If you don't nominate the driver in time, you will have to pay the full penalty amount of \$980.00 and face further action.

What should I do now?

Name the driver who committed the offence by following the instructions **over the page**. If you name the driver, **do not send payment as a new penalty notice for \$196.00 will be issued to the nominated driver. False nomination is a serious offence.** You can view other ways to finalise this notice over the page.

What will happen if I do not nominate the driver by the due date?

You will receive a separate penalty for the offence of failing to nominate. This carries a penalty of more than \$1300 for a first offence and over \$3000 for a second or subsequent offence. Courts may issue fines up to \$11000.
