As promised here is the info and quick draft comments for you to consider.

Key points

- Between 15 -29 Nov 2017 three COMCAR vehicles and possibly at least one AFP vehicle were significantly damaged due to APH security bollards on the Senate-side slip road.
- The cause of incidents has not be declared; however, it is likely to be due to changes to operational
 procedures of the bollards and this change not be communicated to the DPS staff in APH.
- The cost of repairing the damage to the three COMCAR vehicles was \$28,420.

Background

Security upgrades to Parliament House has resulted in periods of restricted vehicle access. COMCAR worked with APH staff and contractors to ensure COMCAR services continued at Parliament House during the construction phases. This work is still ongoing. Access to the respective House of Reps and Senate slip roads was the major concern. After numerous meetings, the following overarching guidance was provided. For all sitting periods, access to the Senate slip road would always remain open; however, on the Reps side, access to their slips would not be available for a single two-week sitting period.

At 16.39 on Friday 10 Nov 2017 COMCAR received an email explaining that the access to the Senate slip road would be changed for the next sitting week – commencing Sun 12 Nov. While the slip road was still in-use, the process to proceed through the protective bollards had changed.

COMCAR Action

After receiving the email regarding the change to bollard operations, national office and depot COMCAR staff ensured that a messaging strategy was put in-place to communicate the change to its 180+ casual drivers. This included emailing staff, verbal briefs in the depot when staff started their shifts, posters and electronic notice board graphics.

The first incident occurred on 15 Nov. Initially we general consensus was that the cause of the accident was due to driver error.

After the second incident on 26 Nov and further investigations with other drivers, it emerged that the bollards were not operating as we had been instructed and drivers felt there was an increased risk of the an accident.

On 27 Nov, COMCAR spoke to and emailed Senate Services at APH to highlight our concern over how the bollards were now operating and the increased risk of further incidents.

On 29 Nov the third incident occurred. COMCAR spoke to and emailed Senate Services at APH and to elevate our concern and explain the actions we were likely to take – directing drivers not to use the Senate slip road. Within 30 minutes, DPS agreed to place a security guard at the bollards to control access.

On 5 Dec, ^S 22 tweets about a recent incident of going through security checks at the bollards on the senate slip road. For driver reports, ^S 22 voiced concerns in the car over the poor security checks of ID cards and also discussed the problems of the bollards damaging cars.




