- Company/supplier 'James Flynn' has been taken to mean **James Peter Flynn Trading as Teller Consulting with an ABN of 69 550 851 629.**

These records relate to all historical invoice/claim payments received by MaPS from the listed parliamentarian (i.e. not based on invoice dates, expense dates, or invoice/claim submission dates etc).

To obtain these records, searches were undertaken across PEMS (current expenses management system which houses work expenses invoice/claim payments from 1 July 2022 onwards, and EMS (legacy expenses management system) for invoice/claim payments prior to 1 July 2022. Records potentially in scope were identified in the PEMS claims compartment only. No relevant records were identified from EMS.
