
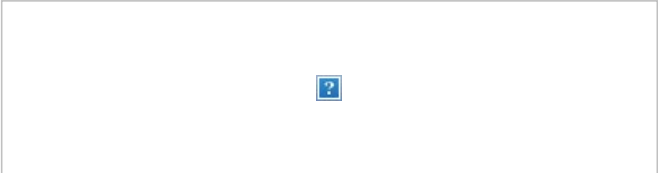

Good afternoon Laurent and Alex,

As you are aware the Attorney General's Department, National Firearms Register proposal and associate funding for a Gateway Review were announced in the 2024-25 Financial Budget.

We would like to meet with you in the coming weeks to discuss the program/project and commence discussions around timing and scope for the first review.

The Gateway Review Process is in place to strengthen governance and assurance practices and to improve project/program management capability across government. It involves a series of short, intensive reviews that are conducted at critical points during a project/program's implementation lifecycle. Gateway is not an audit or compliance process. It is intended to be supportive and forward looking, and provide Senior Responsible Officials with independent assurance and advice to improve project/program implementation and delivery.

Our team administers the process including assembling an independent Review Team to undertake the review.
