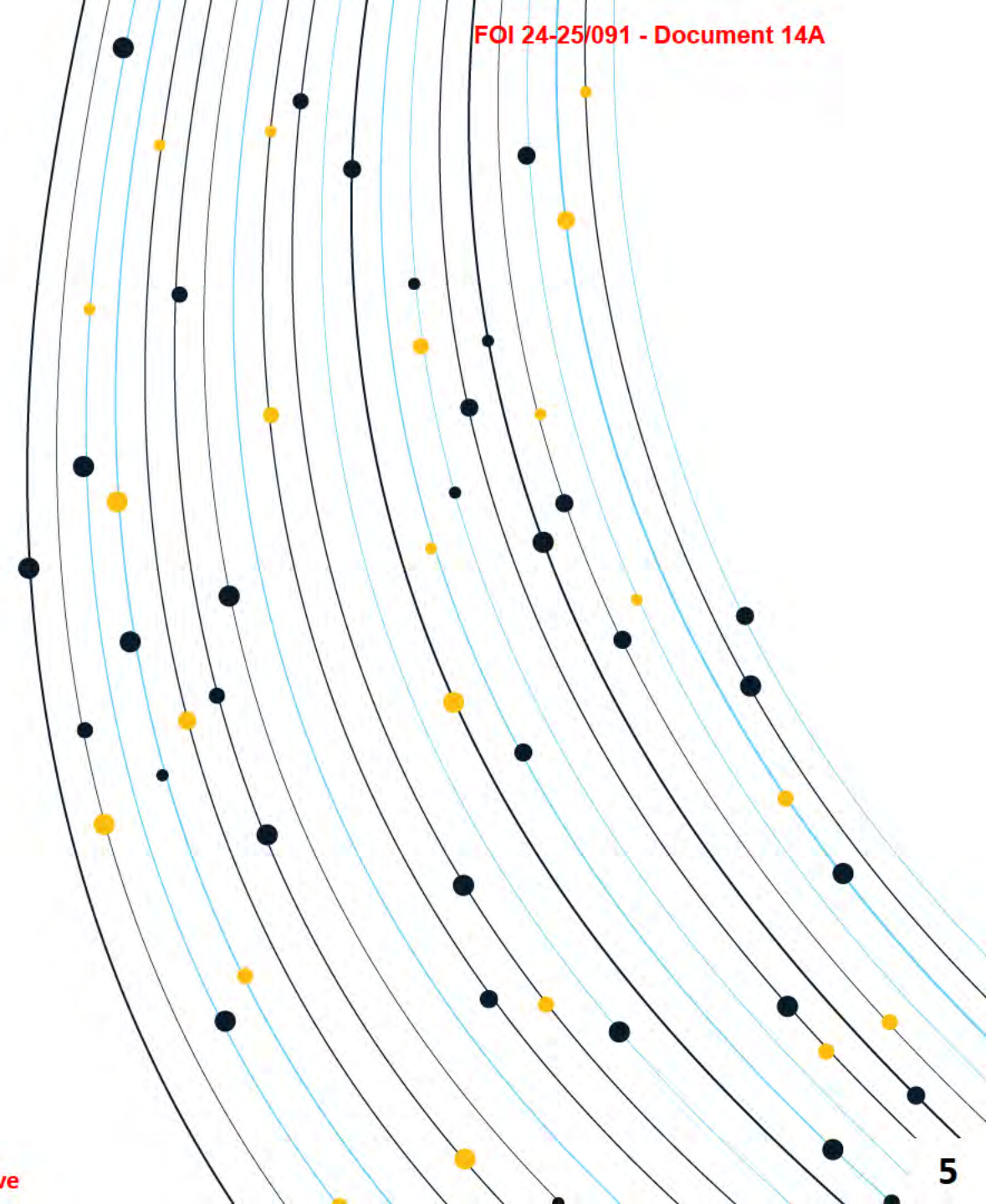

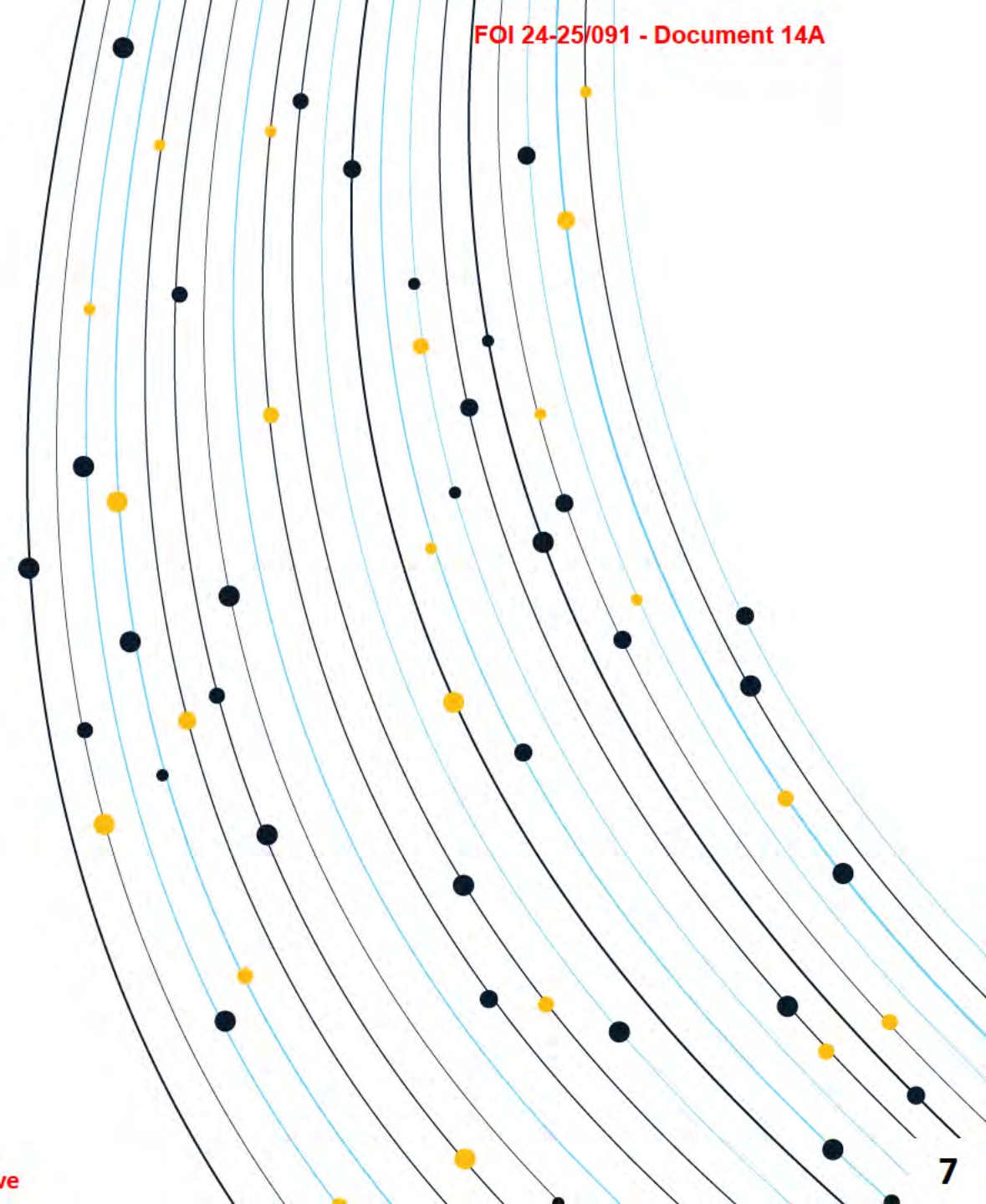

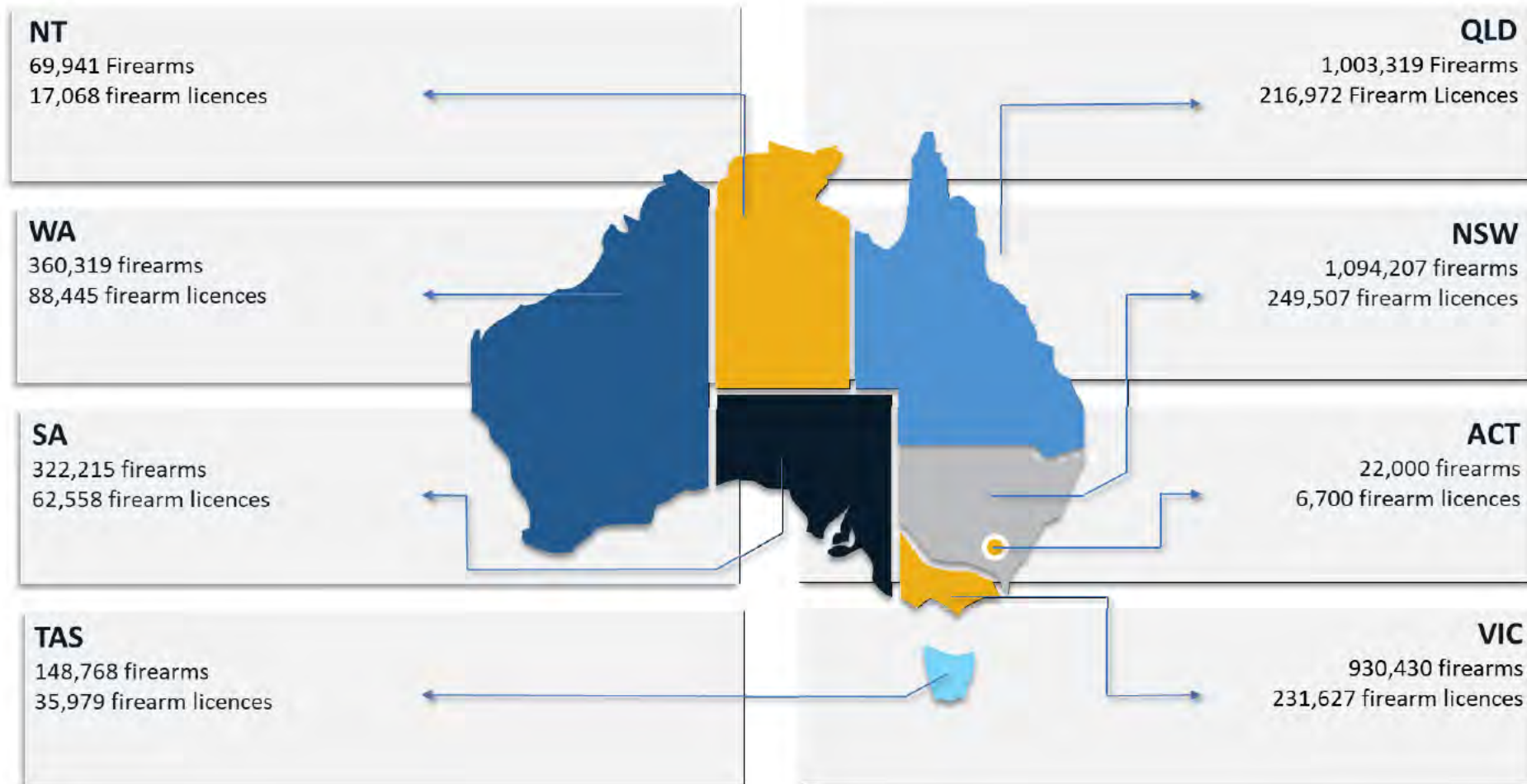
THE PROBLEM

We have some of the strongest firearms laws in the world, however, Australian police officers still don't have access to near real-time, national firearms information that allows them to know:



- where firearms are
- who owns them
- and what other risks to the community and police may exist

THE SOLUTION

A NATIONAL FIREARMS REGISTER (NFR)

The NFR will be an end-to-end firearm, licence and permit information sharing and management ecosystem, comprised of Commonwealth and state and territory firearms registries, portals and management systems.

This will provide a lifecycle view of registered firearms in Australia, delivering timely, consistent, and accurate information on firearms and owners across all jurisdictions

NATIONAL CABINET AGREES TO A HISTORICAL REFORM

On 6 December 2023, National Cabinet agreed to implement a National Firearms Register (NFR), delivering on an outstanding reform from the Port Arthur response in 1996.

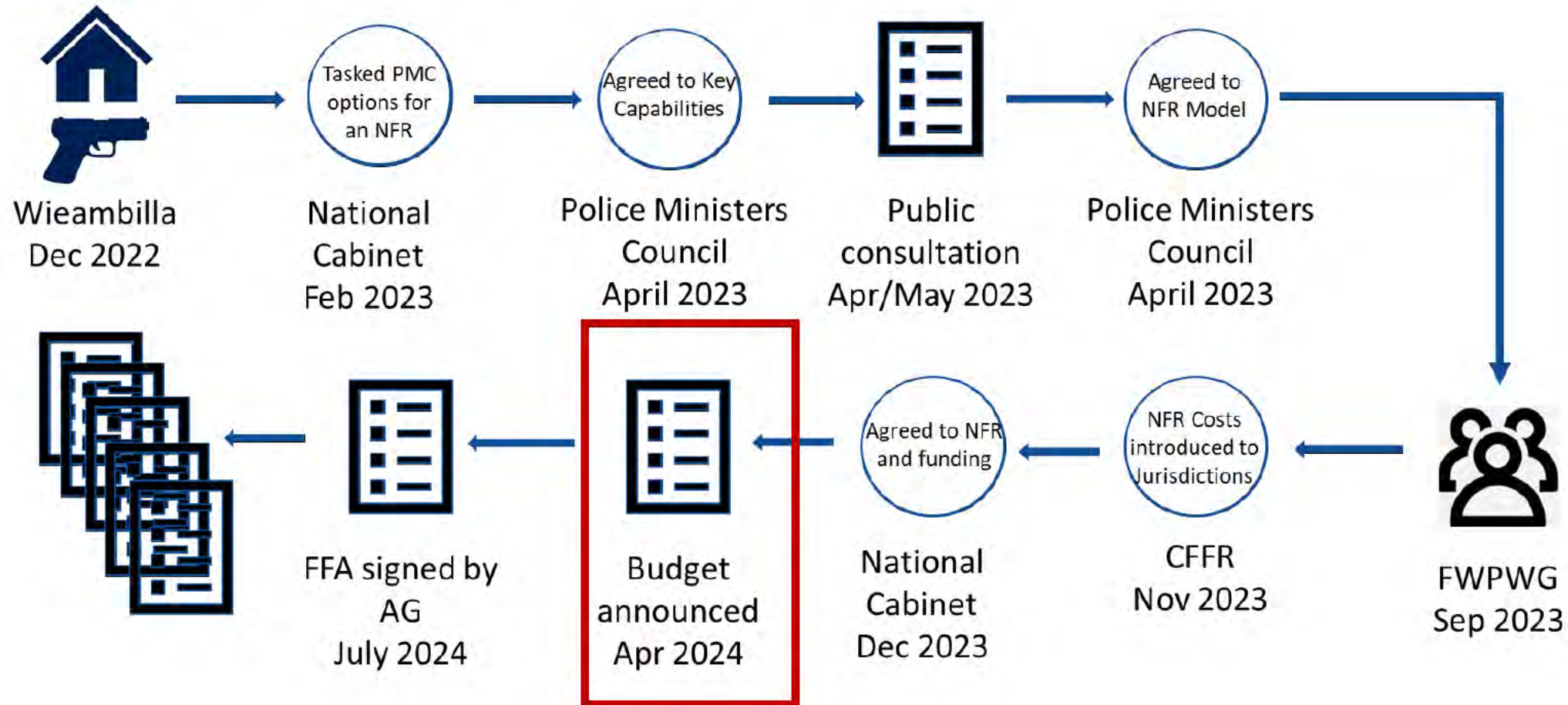

NFR CHRONOLOGY



NFR FUNDING

- The Commonwealth committed \$161.3 million from 1 July 2024 - 30 June 2028 to implement the NFR bringing together firearms information from state, territory and Commonwealth firearm management systems under a national system. The NFR will be implemented under a cost-sharing arrangement with each state and territory receiving Commonwealth and non-Commonwealth contributions to fund the project.
- The Commonwealth funding includes:
 - \$101.8 million to states and territories.
 - \$29.4 million for the Australian Criminal Intelligence Commission (ACIC) to enhance the existing Australian Firearms Information Network.
 - \$7.8 million for Attorney-General's Department (AGD) to lead the policy reform work, and to build an improved import system to better monitor the movement of highly controlled firearms entering the country.
 - \$20.8 million to the Australian Border Force (ABF) to enhance its Goods Management System to align provision of information to the NFR and to increase resources at the border to undertake additional identification, examination and data capture
 - \$1 million for the Australian Federal Police (AFP) to link and integrate existing systems with the Register to support firearms and other data analysis
 - \$0.4 million for Finance to review implementation progress.

FEDERATION FUNDING AGREEMENT SCHEDULE

- The Commonwealth committed \$101.8 million over four years to support states and territories to uplift their respective firearms management systems, improve data quality, and to enable integration to the NFR.
- The National Firearms Register – Federation Funding Agreement – Affordable Housing, Community Services and Other Schedule (NFR FFA) is the mechanism to administer and govern Commonwealth funding to states and territories.
- All NFR FFA schedules were signed by the Attorney-General on 19 July 2024 and sent to the respective jurisdictions' Police Ministers on 22 July 2024. To date, NT, SA, NSW and TAS have countersigned the FFA.
- Where FFAs have been executed, the Commonwealth has commenced the disbursement of funds, subject to jurisdictions meeting milestone requirements.

NFR PROGRAM OVERVIEW

- The NFR capability will provide frontline police officers with near real-time information on firearms, suppressors permits and licence holders.
- The NFR capability will link firearms data with other relevant police and government information, including information from the National Criminal Intelligence System and the courts, to better enable law enforcement assess firearms risks.
- The NFR Program is a collaborative effort between Commonwealth partners – Attorney General's, Australian Criminal Intelligence Commission, Australian Border Force, Department of Defence and the Australian Federal Police – and state and territory police agencies.

- **Primary Business Benefits:** Improve Police and Public Safety.
- **Timeframe:** July 2024 to June 2028 (4 years)
- **Funding:** \$161.3 million (4 years)

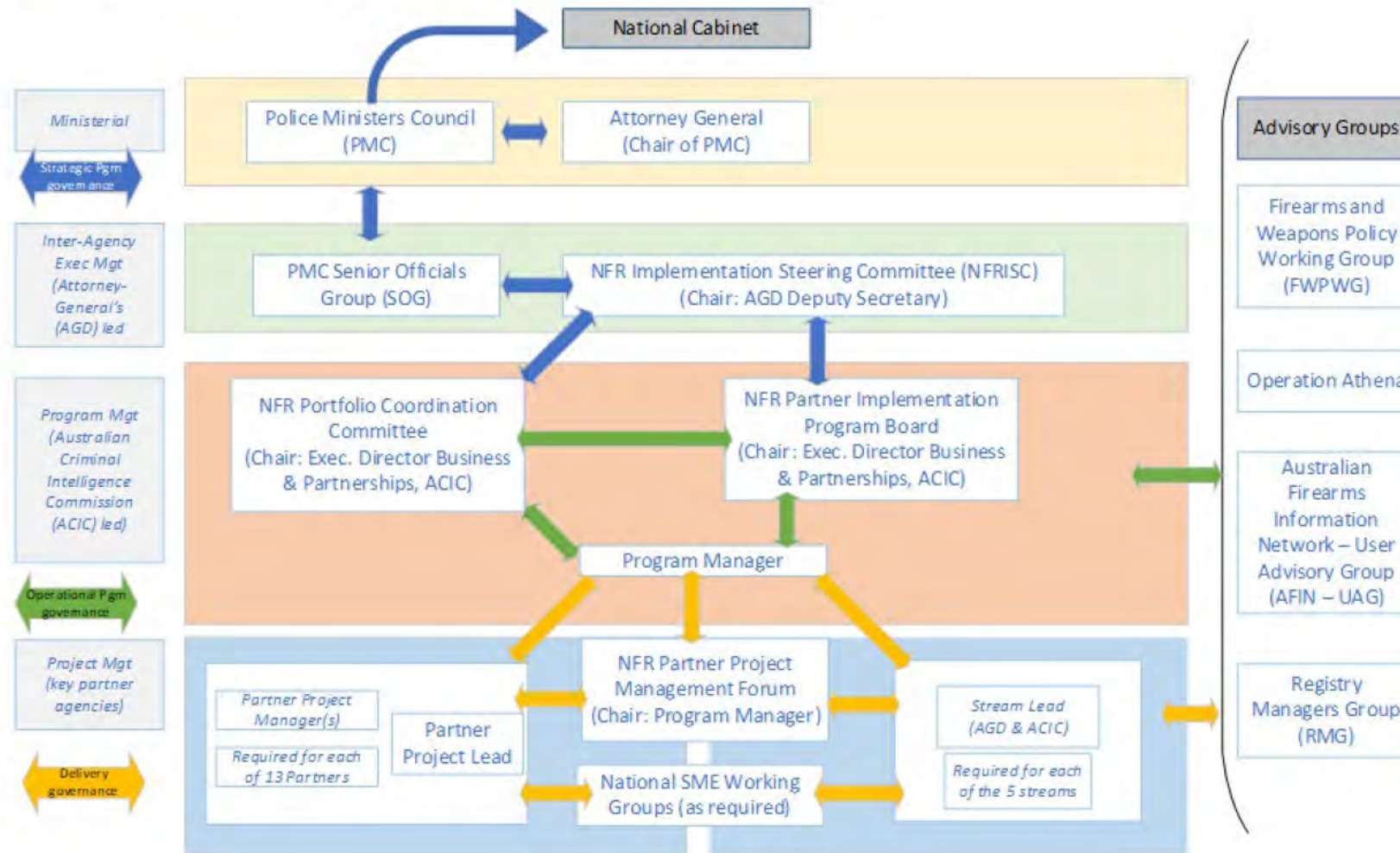

NFR STRATEGIC OBJECTIVES

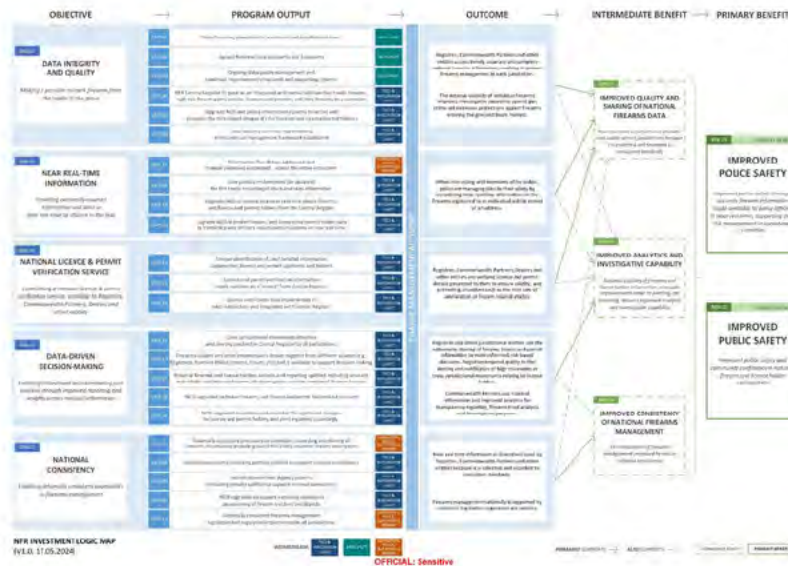
As agreed by Australian Criminal Intelligence Commission (ACIC), the Attorney-General's Department (AGD), Australian Border Force (ABF), the Department of Defence, the Australian Federal Police (AFP) and all state and territory firearms registers, the objectives of the NFR are:

- **Data Integrity and Quality** - Making it possible to track firearms from the cradle to the grave
- **National Consistency** - Enabling nationally consistent approaches to firearms management
- **Data-Driven Decision-Making** - Enabling data-driven decision-making and analysis through improved reporting and insights across national information
- **Near real-time information** - Providing nationally-sourced information and data in near real time to officers in the field
- **National License and Permit Verification Service** - Establishing a national licence and permit verification service, available to registries, Commonwealth partners, dealers and other entities

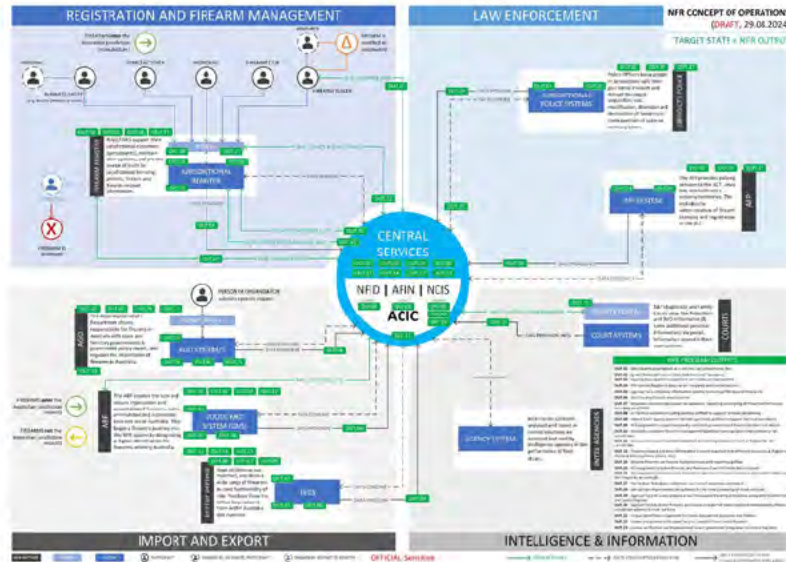


INVESTMENT LOGIC MAP AND EXPECTED BENEFITS



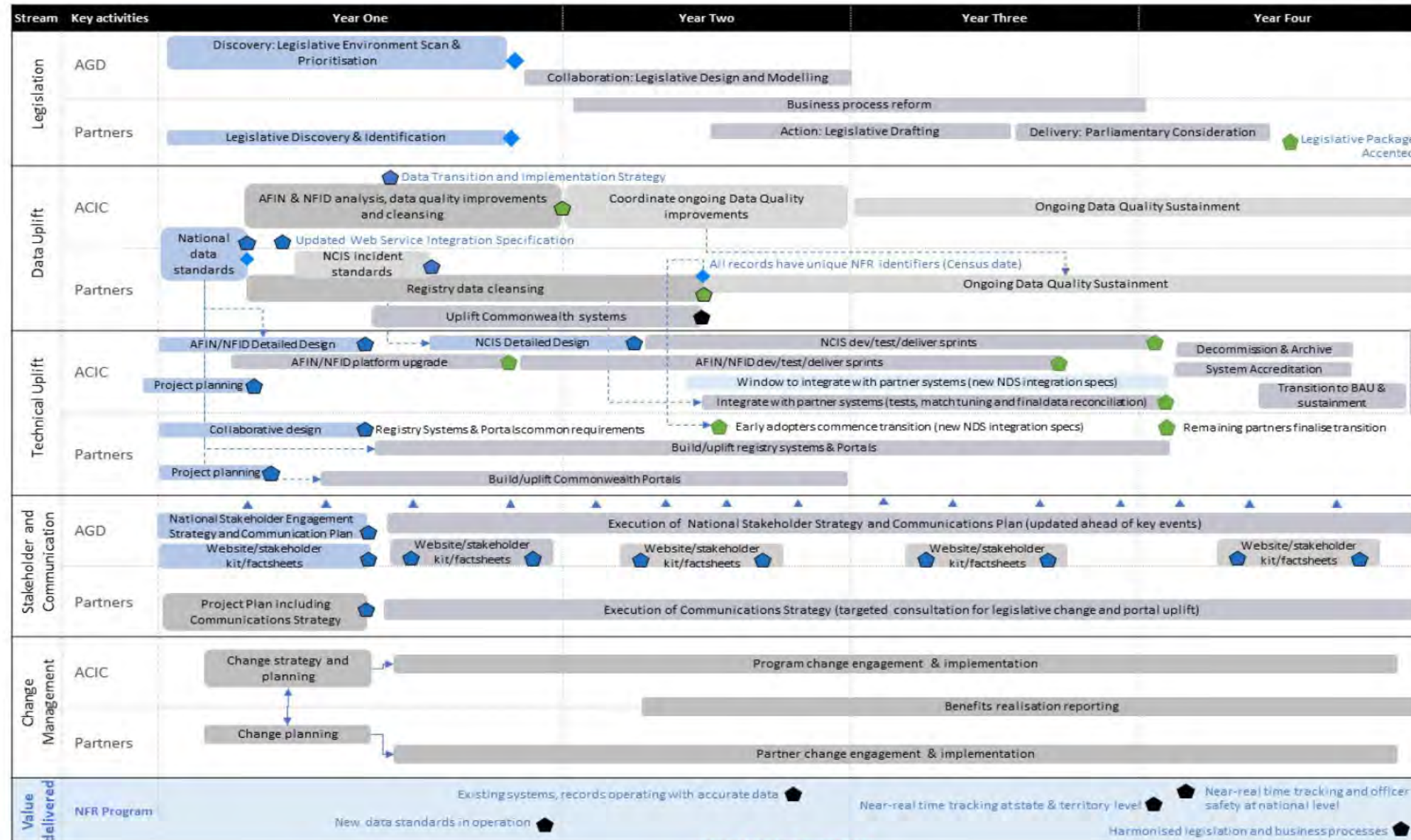

CONCEPT OF OPERATIONS MODEL WITH PROGRAM OUTPUTS OVERLAY



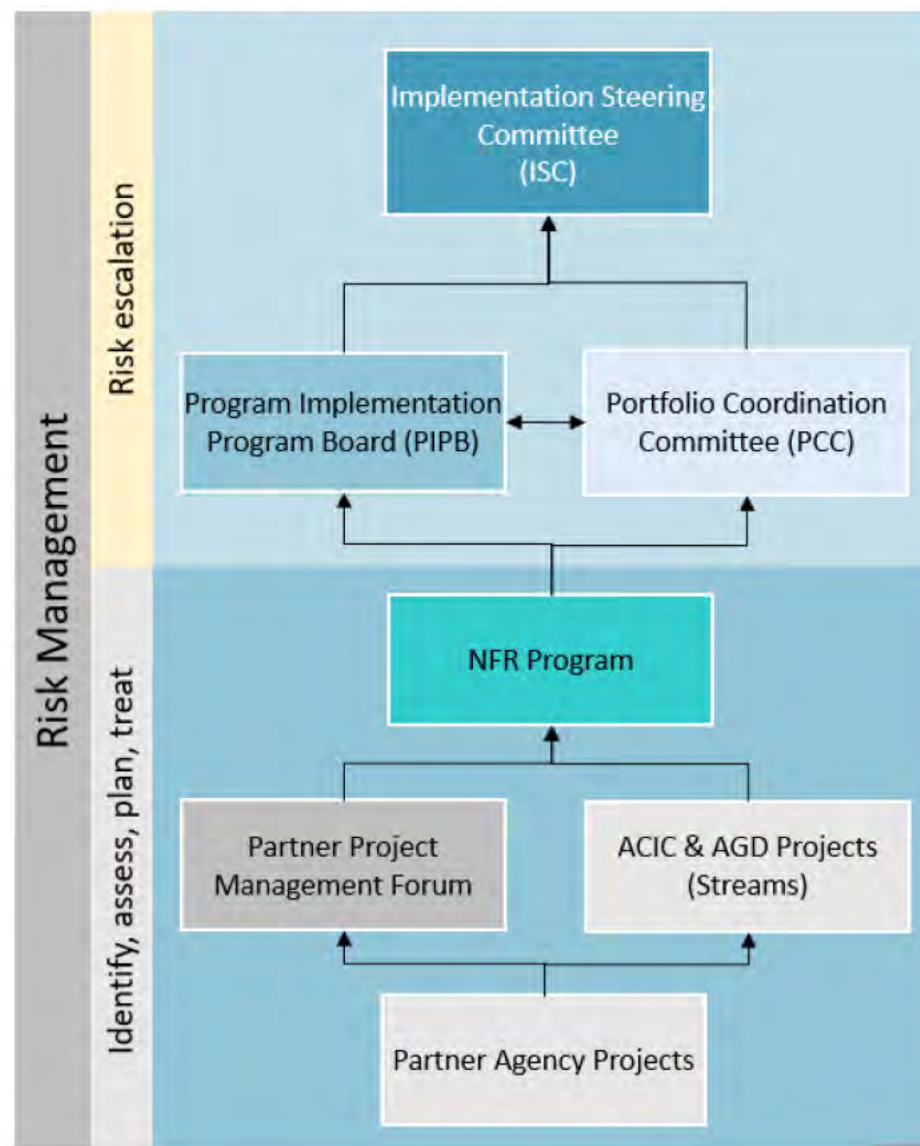

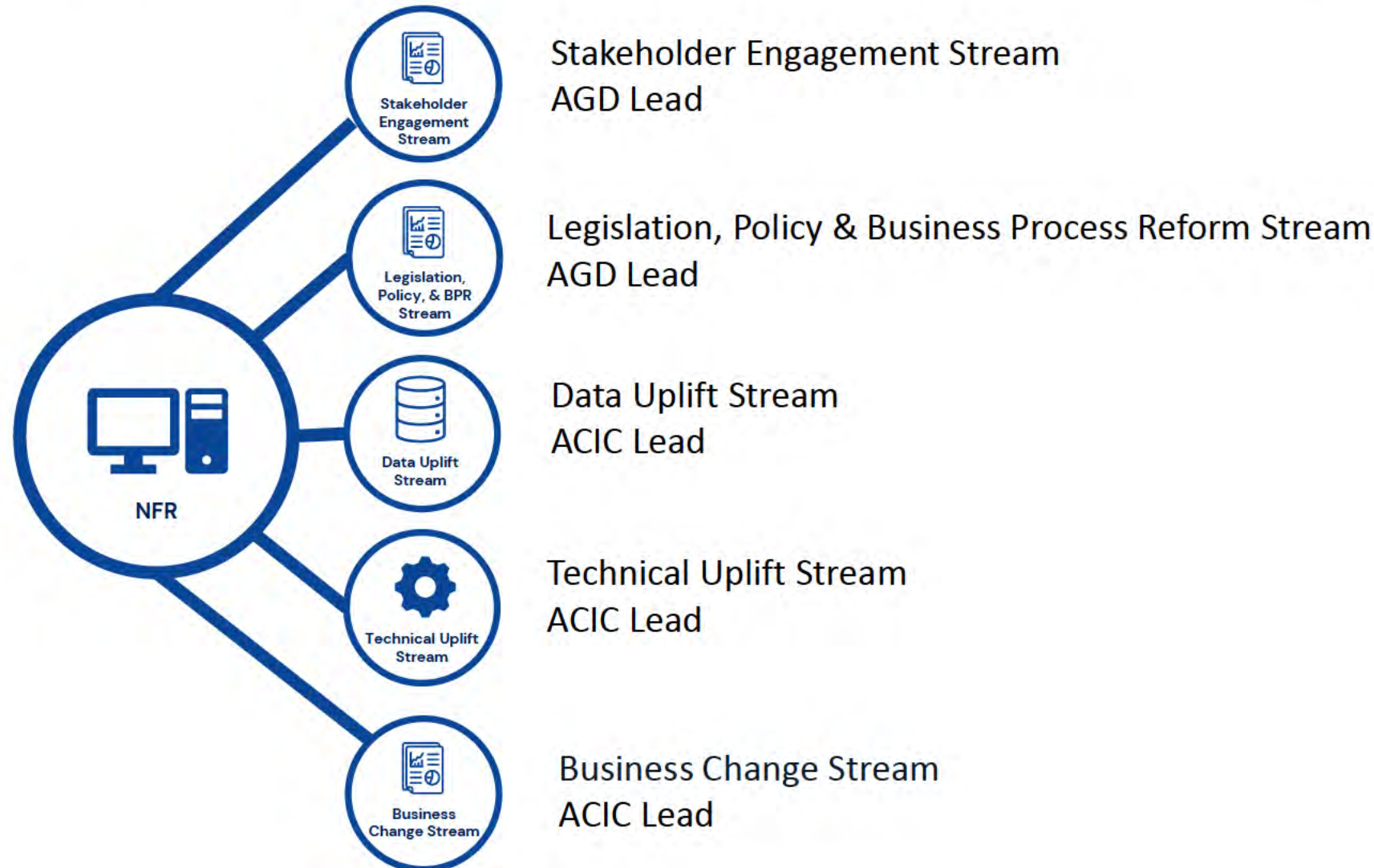


RISKS AND ISSUES MANAGEMENT

- This diagram shows the levels of project and program risk identification and how they report through the risk governance structure for risk and issue management action and treatment plans.

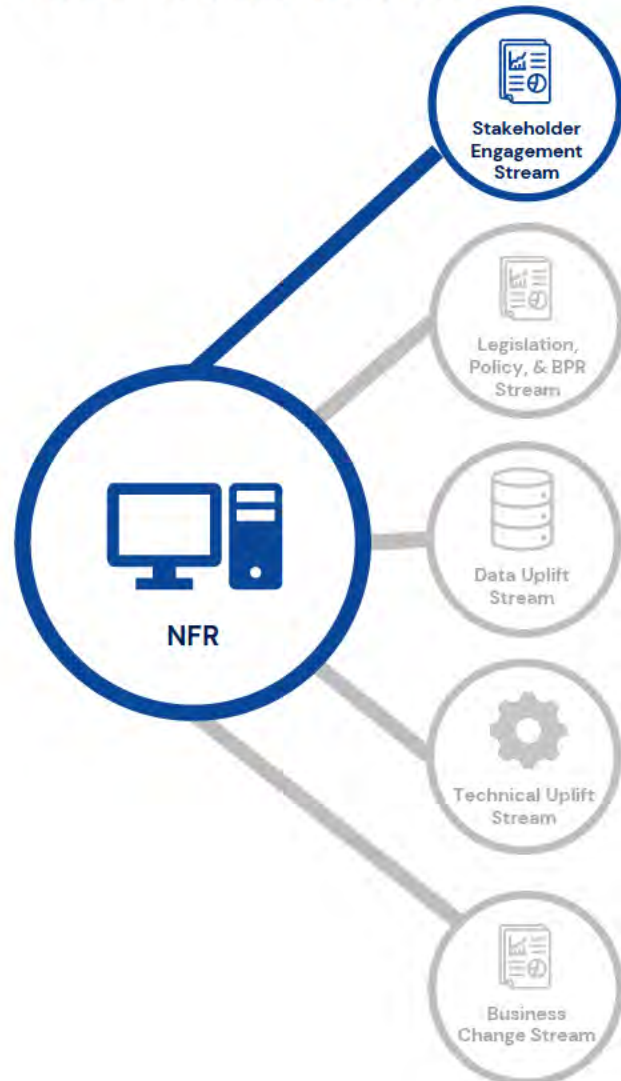

Context

On 1 July 2024, the National Firearms Register (NFR) project officially commenced following National Cabinet agreement on 6 December 2023. The NFR is of national significance and represents the largest uplift of Australia's firearms management systems in almost 30-years. As such there is significant government and public interest and scrutiny – including pressure to meet the needs of all relevant stakeholders.

The NFR will predominantly impact and benefit government departments – especially in law enforcement, the firearms industry and more broadly the Australian public. The Commonwealth is committed to understanding the views and concerns of key stakeholders and the broader Australian community as we work to collaboratively to deliver the NFR with states, territories and relevant Commonwealth agencies. The NFR Implementation Program, through the Attorney-General's Department (AGD) as stream lead for stakeholder engagement, will coordinate nationally consistent messaging so misinformation doesn't prevent the NFR from meeting its objectives. The Stream will report to the NFR Program Manager and relevant working groups.

Approach and Scope

Activities within the stakeholder stream will be conducted in stages:

- **Discovery** – a review of current stakeholder forums and communication mechanisms will be conducted to determine existing arrangements within jurisdictions that can be leveraged.
- **Design and develop** – a national stakeholder engagement and communication strategy will be developed including whole-of-government talking points, questions and answers, and a media protocol. The strategy will also include fact sheets and suggested text for dissemination to industry, advocacy groups and the community through jurisdictions' preferred channels. The strategy will be updated over the implementation period, and in particular, at event milestones (i.e. legislative change or portal uplift) and in advance of significant anniversaries and events (i.e. Port Arthur massacre on 28 April and Wieambilla shooting on 12 December each year).
- **Delivery** – all relevant Commonwealth and state and territory agencies will conduct targeted consultation with stakeholders as per their stakeholder strategies and communicate national messaging and information as per the national stakeholder engagement and communications strategy.

Roles and Responsibilities

Attorney-General's Department

- Conduct review of current forums.
- Design and develop a national stakeholder engagement and communication strategy.
- Design and develop fact sheets and agreed messaging that partner agencies can distribute to their stakeholders.
- Update whole-of-government talking points and questions and answers based on common themes coming through media requests or ministerial representations nationally.
- Maintain a website with national information on the NFR's implementation.
- Report progress, issues/risks and troubleshooting through relevant governance channels.
- If required, provide support to partner agencies in stakeholder engagements and consultations.
- Communicate with national bodies.

Partner agencies (state and territory police and Commonwealth agencies)

- Develop a jurisdictional engagement and communications strategy for targeted engagement with firearms dealers, users, groups. It should include an approach for engaging with regional, rural and remote communities, CALD and Aboriginal and Torres Strait Islander peoples.
- Follow the agreed media protocol and use whole-of-government agreed talking points in communications.
- Advise AGD of key questions and issues arising in correspondence/forums or other channels, so AGD can develop new nationally agreed talking points or information for dissemination.
- Disseminate information within the agreed timeframe to avoid misinformation and inconsistencies across jurisdictions.
- Facilitate engagement and consultation as per the jurisdictional strategy.

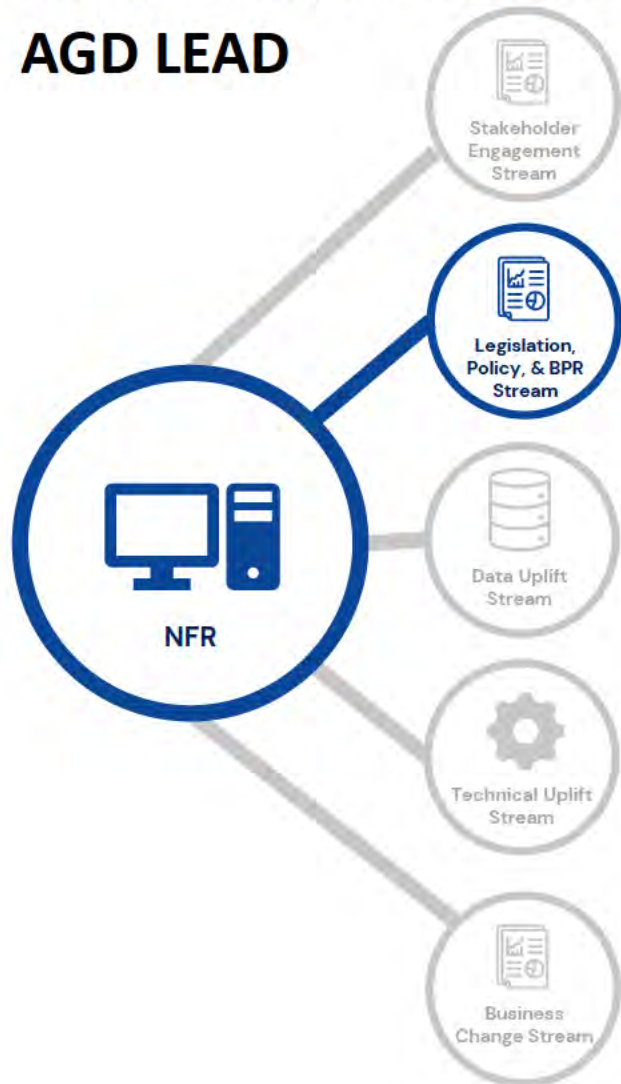
External stakeholders

- Contribute to consultations in areas that directly impact their operations.

- Providing national coordination to ensure consistency and alignment of legislation, and to minimise legal and operational risks to the NFR meeting its objectives.

- Conduct an environmental scan of current legislative and regulatory settings related to firearms management, information sharing and alignment with the National Firearm Agreement (NFA).

- Engage in collaborative co-design and seek national agreement on the required legislative and regulatory measures of each partner agency.

- As required, all relevant Commonwealth and state/territory agencies will action new/amended legislation and new/amended regulation changes and action any related changes to internal policies and processes.

- Report progress, issues and risks to the NFR Program Manager (ACIC) and through relevant NFR governance channels.



National Firearms Register Legislation Stream

Context

The National Firearms Agreement (NFA), initiated in 1996 and revised in 2017, set out minimum standards in relation to the regulation of firearms. Since then, the Commonwealth, states and territories have progressed and applied legislation and business practices to suit their unique circumstances which has resulted in variations between jurisdictions. While the ability to share information with a national information sharing hub is set out in the NFA, the National Firearms Register (Register) build and its integration to existing firearms management portals and systems will be a new national capability. As such, legislation, regulation and business practice will need to be reviewed to ensure lawful integration and information sharing to the register. AGD will provide national coordination to ensure consistency and alignment, and to minimise legal and operational risks to the Register meeting its objectives.

Approach and Scope

Activities within the legislative stream will be conducted in stages.

- **Discovery** – environmental scan of current legislative and regulatory settings related to firearms management, information sharing (including privacy) and alignment with the NFA. This will include identifying related legislative ‘themes’. Themes will further identify any specific details that may require changes and alignment as part of the Register build. This stage will also prioritise themes and sub-themes/items – must-have, should-have, could-have, and future.
- **Collaboration** – co-design and national agreement on the necessary legislative and regulatory measures needed for the Register’s function – this will include greater alignment of definition and terminology. Negotiations and decisions be made through the Firearms and Weapons Policy Working Group with input and oversight from the NFR Programme Manager and related NFR bodies. A consensus model will be used to maximise consistency – with flexibility applied to take into account jurisdictional context and needs. Papers and other supporting documents will be produced to support drafting.
- **Action** – new/amended legislation and regulation drafted by states and territories, and any related changes to internal policies and processes.
- **Delivery** – proposed bills introduced into Parliament following any necessary review and scrutiny stages.

Roles and Responsibilities

Attorney-General’s Department

- Coordinate the national environmental scan.
- Map current legislative and regulatory settings.
- Lead the national co-design process, including reaching agreement with states and territories.
- Reporting progress and troubleshooting through relevant governance channels.
- Assist states and territories in their legislative change processes, including drafting supporting documentation.
- Ensure compatibility with Commonwealth legislation, including assessing any Constitutional risks.
- If required, provide support in stakeholder engagements and consultations regarding legislative amendments.
- Coordinate Commonwealth legislative and regulatory changes.

State and Territory Police/Justice Agencies

- Engage in this activity with the intent of:
 - ensuring the must-have functionalities of the Register and its respective registries and portals;
 - maximising national legislative, regulatory and related alignment to improve national consistency;
 - improving user and frontline officer experiences; and
 - collaborating and sharing information with jurisdictions to assist in achieving national consistency of legislation.
- Communicate and manage individual state/territory legislative and regulatory requirements
- Commit to regular engagement.
- Provide expertise to produce content for the working documentation.
- Facilitating stakeholder engagement and consultation where needed.
- Drafting and progressing the required legislative and regulatory change.

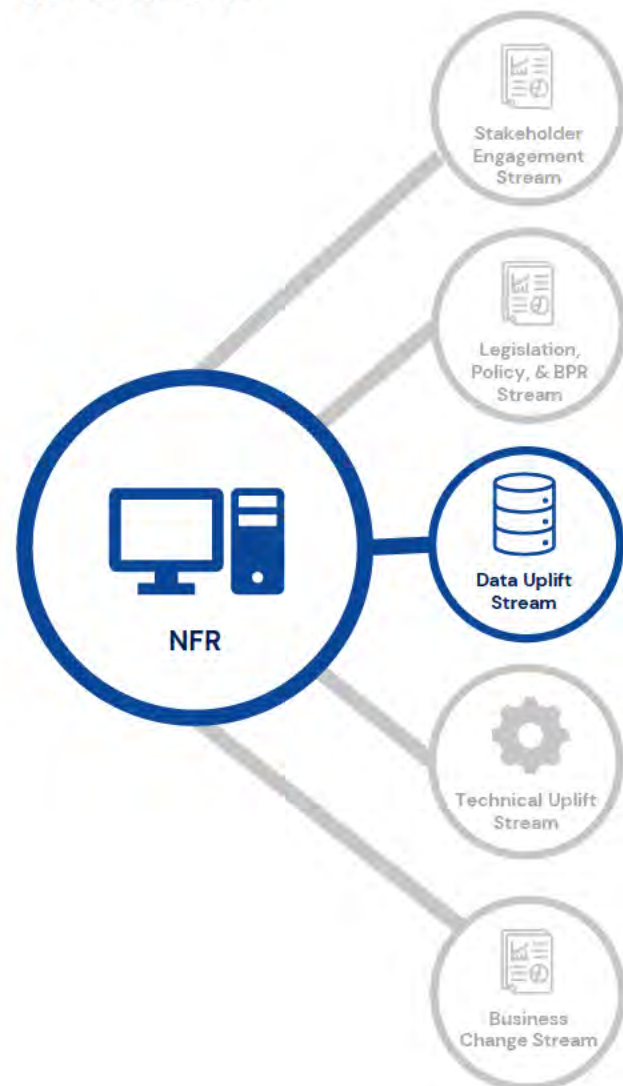

- Deliver a National Data Standard (NDS) to:
 - Standardise rules and guidelines for the efficient exchange of mandatory, core and conditional information used for record matching and maintaining data integrity
 - Definitions relating to the NFR and firearms
 - NFR partners and their responsibilities
 - Data quality risks and controls for ongoing management.
- Undertake ACIC systems (AFIN, NFID) analysis, data quality improvements and cleansing to align with the NDS.
- Develop data cleansing algorithms to support partner agencies with their data cleansing and remediation activities. Provide data advice and support across all aspects of the NFR operating model.
- Collaborate with partner agencies to develop a Data Transition and Implementation Strategy to guide, direct and prioritise data cleansing and remediation activities that plans out how the NFR Program transitions data from current to the future state.
- Support ongoing data quality sustainment and continuous improvement to ensure the NFR's concept of operations continues to be accurate, relevant and enduring.



National Firearms Register Data Uplift Stream

Context

The National Firearms Agreement (NFA), initiated in 1996 and revised in 2017, set out minimum standards in relation to the regulation of firearms. Since then, the Commonwealth, states and territories have progressed and developed firearms data items, data management and business practices to suit their bespoke firearms management systems and processes which has resulted in data variations between jurisdictions. While the ability to share information with a national information sharing hub is set out in the NFA, the National Firearms Register (NFR) build, and its integration points, with existing firearms registry systems will bring forth a new national capability. As such, the data uplift stream is integral and a key dependency on the delivery of the NFR. The data uplift stream will deliver nationally consistent data for firearms from cradle to grave that will be accurate and reliable for use in operational tasking and investigations where firearms, persons and permits/licences are key data points.

Approach and Scope

Activities within the data uplift stream will be conducted in phases over the four years.

- **National Data Standards** requires the coordinated and collaborative development of the National Data Standards which is a key dependency for the delivery of the remainder of the NFR program
- **ACIC systems analysis, data quality improvements and cleansing** will undertake the development of data cleansing algorithms to cleanse key focus areas within the Australian Firearms Information Network (AFIN), Nation Firearm Identification Database (NFIS) and National Criminal Intelligence System (NCIS).
- **Updated Web Services Integration Specification** will be produced to support AFIN
- **Data Transition and Implementation Strategy** will guide the development direction of data cleansing algorithms and the key focus areas for cleansing activities to optimise cleansing impact
- **Data Quality improvements** will deliver the data cleansing algorithms and perform cleansing activities across the concept of operations. It also includes supporting partner agencies in their data cleansing and remediation activities
- **Ongoing Data Quality Sustainment** that will ensure the National Firearms Register concept of operations continues to be accurate, relevant and enduring

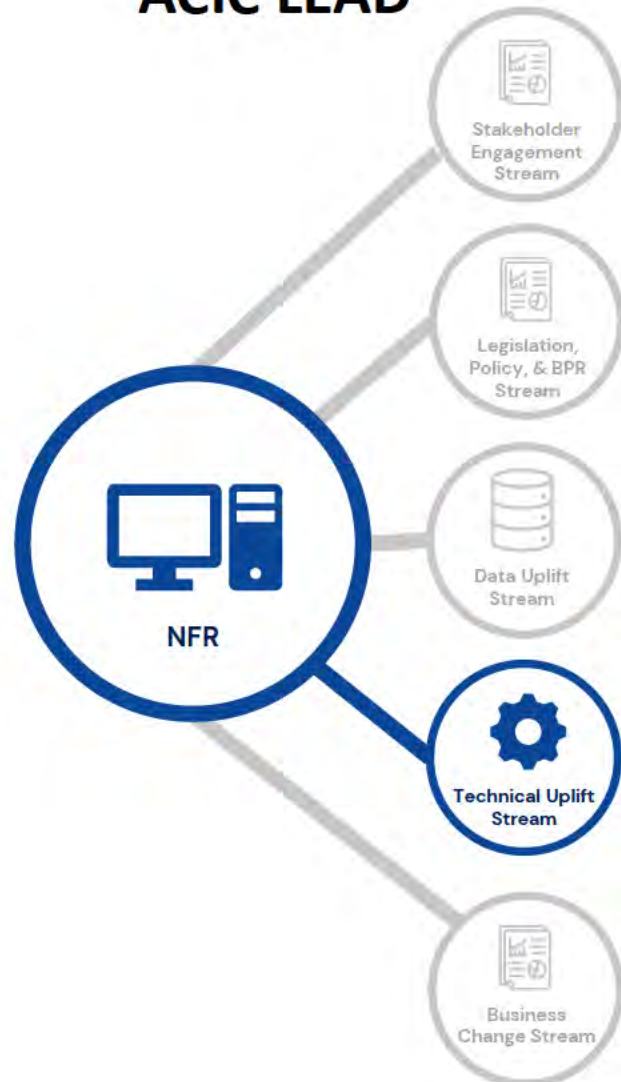

Context

The National Firearms Register Program (NFR Program) is a collaborative effort between state and territory police agencies and Commonwealth partners – AGD, ACIC, Australian Border Force, Department of Defence and the Australian Federal Police. The NFR Program will deliver improvements across all Commonwealth, state and territory firearms, licenses and permits management functions, called the NFR Operating Model, for the purposes of police and community safety. It does this by ensuring police have timely and accurate information required to assess the firearms risk posed by individuals and locations. It also identifies risks for movement of registered firearms to the illicit market.

The Technical/Integration Uplift Stream monitors technical solution and integration work across all partner project for the purposes of program reporting; coordinating integration planning and delivery; risk/issue mitigation and resolution; and technical assurance. Specifically, within ACIC this is focussed on the technical uplift of ACIC systems (AFIN, NFID and NCIS) and their integrations internally and externally with partner systems to deliver the federated technical solution that underpins the NFR Operating Model.

Approach and Scope

The Technical Uplift Stream will build and maintain a network of professionals across partner projects for the purposes of sharing knowledge and innovation, and coordinating delivery of the federated, integrated technical solutions that enable the NFR Operating Model.

Activities within the technical uplift stream will be conducted in phases over the four years.

- **Partner project delivery** - requires detailed design for national consistency and NFR requirements, followed by the build, test and delivery of the new/upgraded technical solutions
- **Integration with partner systems** - will cover the AFIN/NFID and NCIS integration points with partner systems adhering to the NFR National Data Standards
- **Monitoring, reporting and problem resolution/escalation** – ongoing program governance of stream responsibilities and deliverables
- **System Accreditation** - ensures the National Firearms Register platforms and integration points with partner agencies are robust, secure and meet cyber security standards
- **Transition to BAU and Ongoing Sustainability** - ensures the National Firearms Register concept of operations continues to be supportable and enduring
- **Knowledge sharing & innovation** - collaboration on GovTeams to share insights, lessons learned, innovative solutions to business problems and other knowledge to advance solution quality outcomes

Roles and Responsibilities

Australian Criminal Intelligence Commission

- Establish a network of partner representatives responsible for technical delivery.
- Develop and maintain communication/collaboration channels across partner technical projects for knowledge sharing and reporting.
- Maintain register of assurance activity by partners for reporting against DTA Tier 2 assurance requirements.
- Maintain a register of dependencies, decisions, risks and issues across partner technical projects – facilitate working groups to resolve issues or escalate.
- Coordinate and produce consolidated reports of technical/integration progress against schedules.
- Deliver ACIC's technical/integration solutions – including integration of all relevant partner systems.
- Coordinate and facilitate collaborative design activities with partners for national consistency and NFR-related system build/uplift.

State and Territory Police/Justice Agencies

- Collaborative design of the registry systems and portals for national consistency and NFR-related system build/uplift
- Partner technical projects to:
 - Build/uplift jurisdictional registry systems and portals
 - Integrate with ACIC national systems where applicable
 - Integrate with reference systems
- Share partner project progress with NFR Program / Technical Uplift Stream for consolidated reporting of progress, dependencies, decisions, risks and issues and cooperate in resolving issues
- Share partner project technical assurance reporting to feed NFR Operating Model DTA Tier 2 assurance requirements

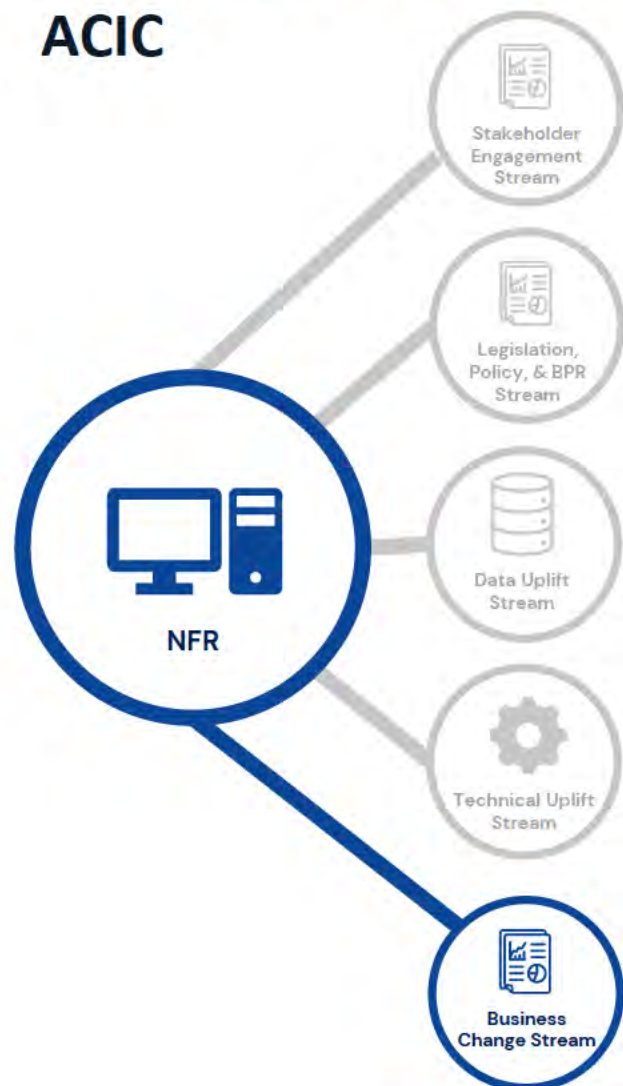

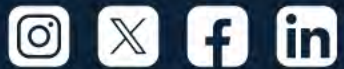
