

As discussed, I've pulled together quickly the **attached** paper as Richard W asked Cameron to prepare something on the Port of Darwin election commitments.

s22. Would greatly appreciate your review of the paper – adding anything else that you think could be relevant to bring to Richard's attention at this early/initial stage. I would normally approach s22, but I understand she is currently on leave. Would you be okay, together with Cameron, as the primary point of contact for this document?

I've also had a few conversations with GDD colleagues (s22, copied) – who are having direct conversations with PM&C, TSY and others about this particular issue. I understand that GDD would lead on this issue in the Incoming Government Briefing, consulting closely with CID and PCD.
